## Statement to the Richmond City Planning Commission

Delivered by Stephanie Power, Community Engagement & Programs Manager, RVA Rapid Transit

Good afternoon, members of the Planning Commission. My name is Stephanie Power, and I serve as Community Engagement & Programs Manager for RVA Rapid Transit. I am here today to voice strong support for installing a bus boarding platform at Brauers Lane & Mechanicsville Turnpike—a critical improvement for the safety and dignity of transit riders, pedestrians and the surrounding community.

For too long, bus riders (who are also pedestrians) at this location have been forced to wait in unsafe conditions, navigating unpredictable and high-speed traffic to cross the street. As someone who also commutes by bike, I know firsthand the dangers of navigating roads where infrastructure prioritizes cars over people. A bus boarding platform here would create a safe, level space for riders to board and exit the bus, comply with ADA requirements to ensure accessibility for those with mobility devices, reduce conflicts with traffic (for riders and also for bus drivers, who often get "boxed in" when pulling to the curb for pickup/drop-off, then merging back into a steady flow of traffic). We understand there is also the possibility to add, under the Richmond Connects' plan, benches and shelter on the platform, which we absolutely support.

To maximize safety, we strongly recommend hardened centerlines to discourage vehicles from illegally passing stopped buses. Additionally, we support the city conducting community surveys post-installation to ensure this improvement effectively meets the needs of those who rely on it.

This is a long-overdue step in making Richmond's streets safer and more equitable. We ask that the Planning Commission approve these plans that the Richmond Connects team has put much intention into, responding to the many voices of this very community who are concerned and have asked for such safety measures for this corridor. We encourage bus riders and advocates to speak up in favor of this necessary change.

We are writing in support of efforts to install platform bus stops at Mechanicsville Turnpike and Brauers Lane.
