By virtue of the authority vested in the United States of America, Commonwealth of Virginia, Virginia Code of Laws and the Richmond City Charter: The Honorable Members of Richmond City Council, the governing body of Richmond, Virginia, in the United States of America, do hereby officially proclaim:

Richmond African American History Month

Whereas, The Honorable Members of Richmond City Council, the governing body of Richmond, Virginia, in the United States of America, do hereby unite in solidarity and common purpose to officially recognize, honor and celebrate the significant contributions that people of African American descent have made in Richmond and the United States of America throughout our nation's history; and

Whereas, Dr. Carter G. Woodson (1875-1950), was a prolific writer, teacher, professor and historian from Buckingham County, Virginia who, as just one of his many accomplishments, became the second person of African American descent to earn a Ph.D. from Harvard University and is credited with organizing and establishing a Negro History Week in February 1926, which was later renamed and expanded into a Black History Month;

Whereas, Growing in recognition and importance over the years, a national month observing African American History in February was officially established in 1976 by The Honorable Gerald R. Ford, President of the United States of America; and

Whereas, The history of the world has shown that continued human progress and the success of society and civilization has been built on a foundation of inclusiveness and diversity of social and racial identity; and

Whereas, Embracing and celebrating our individual and communal racial and cultural identities and commonalities as Americans helps to further bring everyone together and to drive the development of our society;

Now, Therefore, In order to recognize, honor and celebrate the important contributions and history of people of African American descent in Richmond and in the United States of America, Richmond City Council does hereby officially proclaim the month of February each year to be **Richmond African American History Month**; calls this observance to the attention of all Richmond Residents; and, encourages everyone to join in commemorating this important observance and taking the opportunity to learn more about African American History.

Whereas, Arriving at the VCU Medical Center Surgical Suite and enlisting the VCU Maintenance Staff to gather some additional tools, Richmond Department of Fire and Emergency Services: Station 10 A-Shift successfully extracted the baby's arm from the appliance, drastically impacting the amount of limb she would lose; and
