### **RVAH20 Combined Sewer System Program Update**

April Bingham, Department of Public Utilities (DPU) Director, and Robert Stone, DPU Engineering Manager, provided the committee a presentation regarding RVAH20 Combined Sewer System Program update.

*Vice Chair Ann-Frances Lambert asked if the \$50 million allocated for the interim plan was received from American Rescue Plan Act (ARPA) funds.*

Robert Stone stated that ARPA was providing the funds, and he informed the committee that the interim plan received \$150 million from ARPA, which included a \$50 million match from the city, for a total of \$200 million.

Director Bingham informed the committee that there is an affordability clause in place, and if the city has to pay more for the plan, then the funding will come from the city's customers.

*Chair Katherine Jordan asked if ARPA spending deadlines were impacting the city's plans.*

Mr. Stone advised that the ARPA funds that are required to be spent by December would not be much use for the more expensive aspects of the final plan.

Brianna Morring, District Manager with James River Soil and Water Conservation District, provided the committee with an update on the Virginia Conservation Assistance Program with the Urban and Suburban Storm Water Management Program.

*Chair Jordan asked how Council can help advocate for additional state funding.*

Director Bingham stated DPU appreciates any assistance from Council and informed the committee that education, outreach, and advocacy would help.

*Vice Chair Lambert requested Director Bingham to provide Council with more information that the members can add to their newsletters and social media.*

Parker Agelasto, Capital Region Land Conservancy Executive Director, provided the committee with an overview regarding the current operations of the Virginia Conservation Assistance Program for the James River Soil and Water Conservation District.

*Councilor Andreas Addison joined the meeting at 1:18 p.m.*

*Council Member Andreas Addison provided the committee with information regarding ORD. 2023- 188, and explained the purpose of establishing a Public Utilities and Services Commission.*

## Public Hearing

Kevin Cianfarini, Electricify RVA and Beyond Methane RVA member, spoke in support of Ord. 2023-188 and stated the commission would benefit the city in many ways.

*Vice Chair Ann-Frances Lambert asked what the city is doing now that is different from what the commission is proposing.*

Bob Steidel, Deputy Chief Administrative Officer (DCAO) of Operations, informed the committee that the city had a similar commission in the past and that the commission gives Council the opportunity to understand the utilities process. Mr. Steidel stated that commission recommendations would be better presented to Council in October or September, and he also stated that surrounding counties should be included in commission membership.

*Vice Chair Lambert asked if members of the commission would be paid.*

Mr. Steidel advised the committee that the City Attorney would have information on commission member compensation.

*Chair Katherine Jordan stated that Councilor Addison has communicated with city administration on continuing the paper for additional time for review of potential amendments.*

*Vice Chair Ann-Frances Lambert asked to be added as a co-patron of ORD. 2023-188.*

*Member Stephanie Lynch recommended the committee move the paper forward to Council and review potential amendments in the future.*

*The committee had further discussion with Councilor Andreas Addison and DCAO Steidel on moving the ordinance forward and amending the paper later.*

There were no further comments or discussions and Member Stephanie Lynch moved to forward ORD. 2023-188 to Council with a recommendation to approve, which was seconded and unanimously approved.

## Discussion Item(s)

Update on the Honorary Street Sign Process

Joyce Davis, Council Policy Analyst, provided the committee with an update of previous honorary street sign data, and she shared that the amount of dedicated street signs has increased which is warranting the conversation of funding.

Bob Steidel, Deputy Chief Administrative Officer (DCAO) of Operations, provided an overview to the committee regarding honorary street signs. He stated that city administration has prepared the steps needed for the process once Council decides on the process for honorees.

*Member Stephanie Lynch asked if the city budget included honorary street signs as a separate line item, and she also asked what the cost estimate would be for that line item.*

DCAO Steidel stated that there has not been a separate budget line item for honorary street signs in previous years.

Bobby Vincent, Department of Public Works (DPW) Director, informed the committee he does not have a cost estimate at this time but explained that sign installation requires two to four DPW employees and can take up to four hours. Director Vincent advised the budget for the signs would be based on how many signs are proposed for that year.

*Member Lynch asked how the signs are funded currently.*

Director Vincent stated the funds for the signs are currently being provided from the DPW budget. He informed the committee that his recommendation would be that honorary street signs become a Council budget line item.

*The committee had further discussion regarding honorary street signs and discussed other methods to honor people.*

### **Cemetery Update**

Chris Frelke, Parks, Recreation and Community Facilities Director, provided the committee with an update regarding the Evergreen Cemetery and East End Cemetery. Mr. Frelke informed the committee that after some conversations with Councilmembers, he recommends a community engagement special meeting.

*Member Stephanie Lynch asked for the cost estimate for maintaining the cemeteries.*

Director Frelke stated that he would get feedback from the community engagement meeting to understand what the community wants.

*Vice Chair Ann-Frances Lambert requested the cost estimate, to include basic maintenance, prior to the public meeting so the community can start to think about how they would spend the money on each cemetery.*

*The committee had further discussion regarding cemetery maintenance.*

*Vice Chair Ann-Frances Lambert departed the meeting at 2:10 p.m.*

## Staff Report

Joyce Davis, Council Policy Analyst, provided the committee with a staff report. Ms. Davis addressed the committee's request for information on the policy for honorary street naming in the city. Ms. Davis also provided the committee with information regarding the City Charter Commission's upcoming meetings, work sessions, and public hearings.
