AWARDS AND PRESENTATIONS

Councilor Stephanie Lynch, on behalf of Richmond City Council, recognized and honored the public defenders, mitigation specialists, investigators, and staff of the Virginia Indigent Defense Commission, Richmond Office of the Public Defender, for providing essential services which includes legal defense, assistance with housing, job training, mental health, and substance abuse treatment. Councilor Lynch thanked the Richmond Office of the Public Defender and staff for going beyond the call of duty, to ensure that the expectations of justice are met.

CITIZEN COMMENT

Brianna Kilmartin shared with Council her concerns regarding ORD. 2019-343, adopted June 22, 2020. Ms. Kilmartin requested that the city approve remaining pending short-term rental operator applications and that Council initiate legislation to remedy her concerns.

Robert Wheatley, on behalf of the Carytown Merchants Association, addressed Council and requested that the discretionary funding sought by the Carytown Merchants Association be approved to assist with beautification efforts in Carytown. Mr. Wheatley stated the assistance was necessary to help address litter and trash within Carytown. Mr. Wheatley also stated he believed beautification efforts would lead to more business in Carytown and more revenue for the city.

To set the rate of personal property tax relief for qualifying vehicles for the 2021 tax year pursuant to City Code §§ 26-495-26-497.

Citizens were provided an opportunity to offer comments in writing regarding Consent Agenda items prior to the Formal City Council meeting. All written comments received by the Office of the City Clerk were provided to members of the Council prior to the meeting and are included as an appendix to the March 22, 2021 Formal City Council meeting minutes.

Councilwoman Reva Trammell stated her appreciation that all members of Council had joined as co-patrons of ORD. 2021-073. Councilwoman Trammell also stated her appreciation of the Virginia Department of Transportation for its assistance with street paving throughout the 8th Voter District.

Councilor Ann-Frances Lambert stated she met with several civic associations located near the all-way stop signs referenced in ORD. 2020-275, and she informed Council that she believed the ordinance would help increase safety within the surrounding neighborhood.

Vice President Ellen Robertson stated she supported Councilor Andreas Addison's efforts regarding the zoning amendments requested in RES. 2021-017.

There were no further comments or discussions and the **Consent Agenda was unanimously adopted.**

REGULAR AGENDA

The following ordinance was considered:

ORD. 2020-257

To authorize the Chief Administrative Officer, for and on behalf of the City of Richmond, to execute appropriate documents releasing the Richmond Redevelopment and Housing Authority and its successors in interest from the reversionary right of the City contained in a certain special warranty deed concerning the property known as 30 West Jackson Street for the purpose of allowing the Richmond Redevelopment and Housing Authority to sell the property for the development of ~~[a rental housing project for low-income residents]~~ affordable housing. (As Amended)

Citizens were provided an opportunity to offer comments in writing regarding ORD. 2020-257 prior to the Formal City Council meeting. All written comments received by the Office of the City Clerk were provided to members of the Council prior to the meeting and are included as an appendix to the March 22, 2021 Formal City Council meeting minutes.

Sharon Ebert, Deputy Chief Administrative Officer of Economic and Community Development, provided an introduction of the proposed ordinance and addressed background information regarding the proposed development referenced in ORD. 2020-257.

Public Hearing

Janis Allen, Historic Jackson Ward Association president, spoke in opposition of ORD. 2020-257, and stated she did not believe the proposed rental development provided opportunities for affordable home ownership. Ms. Allen also stated she did not believe the proposed development would align with the community vision of current Jackson Ward residents.

Vicki Mollenauer spoke in opposition of ORD. 2020-257, and stated she attended several civic association meetings regarding the proposed development. Ms. Mollenauer also stated she supported affordable housing, but that she did not believe the development offered true affordable home ownership. Ms. Mollenauer further stated the proposed apartment building did not match the aesthetic of the surrounding neighborhood.

Marie Cousins spoke in opposition of ORD. 2020-257, and stated true affordable home ownership should be offered and not rental apartments.

Lynn McAteer, Better Housing Coalition vice president of planning & evaluations, spoke in support of ORD. 2020-257, and stated the area referenced within ORD. 2020-257, was zoned for increased density. Ms. McAteer also stated that the Better Housing Coalition had worked diligently to put forward a high-quality affordable opportunity to rent housing.

Erica Sims, Maggie Walker Community Land Trust chief executive officer, Housing and Development Advisors president, spoke in support of ORD. 2020-257, and stated that the development would provide much needed affordable housing in the city. Ms. Sims also stated the intended target for the development would be individuals with an income between \$31,000 and \$53,000. Ms. Sims further stated that many of the job opportunities listed on the city's website are for jobs with a salary range between \$31,000 and \$53,000.

Mary Kay Huss, Richmond Metropolitan Habitat for Humanity chief executive officer, spoke in support of ORD. 2020-257, and stated that affordable housing options within walking distance to mass transit and jobs was needed in the city.

Heather Crislip, Housing Opportunities Made Equal (HOME) president and chief executive officer, spoke in support of ORD. 2020-257, and stated that the proposed development would help provide affordable housing while also preventing gentrification.

Valerie Burton spoke in opposition of ORD. 2020-257, and stated she would prefer that more single family homes be developed in Jackson Ward, rather than more rental apartments.

Eric Macklin spoke in opposition of ORD. 2020-257, and stated he opposed more rental property being development in Jackson Ward.

Greta Harris, Better Housing Coalition president and chief executive officer, spoke in support of ORD. 2020-257, and stated that the ordinance would allow for the investment of a 67-unit affordable housing development. Ms. Harris also stated current gentrification within the city made it difficult for long-term residents to remain in the city, and she believed the development would provide an opportunity for affordable housing for residents.

Irina Calos spoke in opposition of ORD. 2020-257, and stated she believed more community involvement should have occurred. Ms. Calos also stated that the Richmond 300 Master Plan recommended more tree canopy throughout the city to provide shade. Ms. Calos further stated that the proposed development would not help implement the Richmond 300 Master Plan recommendations.

Lee Alford, Better Housing Coalition multi-family real estate development director, spoke in support of ORD. 2020-257, and stated that more affordable rental housing would allow families to spend more money throughout the city on items other than housing.

Mary Thompson spoke in support of ORD. 2020-257, and stated she believed the Better Housing Coalition would help develop high-quality housing opportunities that would benefit the local community.

Leighton Powell spoke in opposition of ORD. 2020-257. Ms. Powell stated she supported the work done by the Better Housing Coalition, but informed Council that she did not support the proposed development referenced in ORD. 2020-257.

Councilor Katherine Jordan stated that the parties involved with the proposed development should have taken more steps to increase participation in the community engagement process.

Councilor Ann-Frances Lambert stated that a lack of affordable housing was a major crisis for the city. Councilor Lambert also stated that the city should try and fulfill the recommendations made in both the Richmond 300 Master Plan regarding density, and the Strategic Plan to End Homelessness regarding affordable housing.

Councilor Stephanie Lynch stated she believed the city would benefit from the proposed development, as it would address much needed affordable housing in the city.

Councilor Kristen Larson stated she would defer to Councilor Katherine Jordan's concerns regarding the history of the development property referenced in ORD. 2020-257. Councilor Larson informed Council that she would not vote to adopt the proposed ordinance.

Vice President Ellen Robertson stated that families in the city desperately needed affordable housing options, and she praised the work done by the Better Housing Coalition. Vice President Robertson also stated she supported the development and informed Council that she would vote to adopt ORD. 2020-257.

Councilor Katherine Jordan stated that she was not necessarily against the proposed development, but informed members she was concerned that the developer did not engage in enough community discussion. Councilor Jordan also stated members of the community did not

oppose the development, but that Jackson Ward residents wanted to ensure more affordable home ownership opportunities were created, and not just apartments. Councilor Jordan further stated she requested that the Better Housing Coalition add the construction of affordable homes on a portion of the property within the development plan, but was informed the construction of homes would not occur.

Councilor Andreas Addison stated he understood the concerns raised by residents of Jackson Ward, but he believed that the development would provide much needed affordable housing to working residents of the city. Councilor Addison informed Council he would vote to adopt ORD. 2020-257.

Councilor Michael Jones stated he believed the city was in an affordable housing crisis, and he requested that each Council Voter District create its own housing strategy. Councilor Jones also stated that workers in the city needed more options for affordable housing to be able to reside in the city.

Councilwoman Reva Trammell stated she believed that similar affordable housing developments in the 8th Voter District had been a success for the citizens of Richmond, and she informed Council that she supported the proposed development referenced in ORD. 2020-257.

President Cynthia Newbille stated that the city was in great need of quality affordable housing options and that affordable housing was a priority concern for Council. President Newbille informed Council she would vote to adopt the proposed ordinance, and she also stated that she looked forward to identifying potential developments throughout the city to address the need for more affordable housing.

There were no further comments or discussions and **Ord. 2020-257 was adopted:** Ayes 7, Addison, Lambert, Lynch, Trammell, Jones, Robertson, Newbille. Noes 2, Jordan, Larson.
