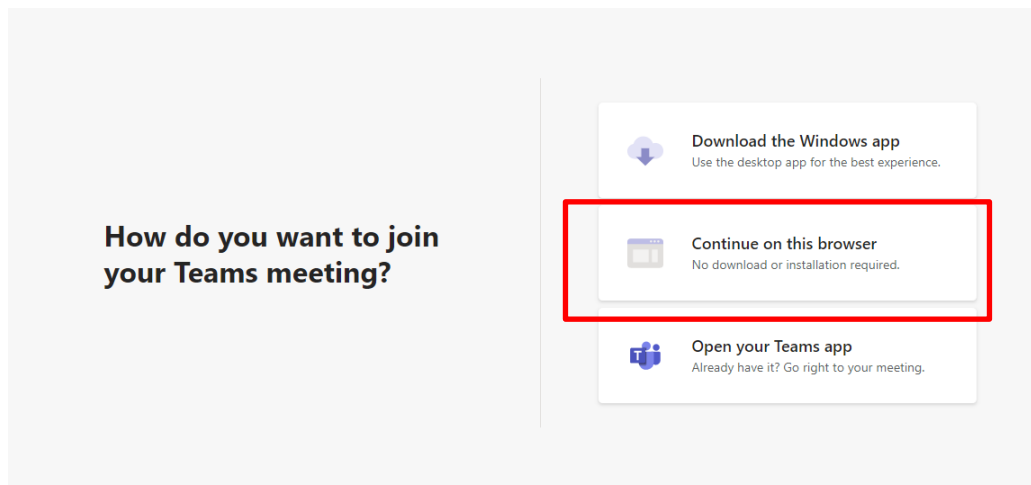
**Accessing the Meeting:**

When submitting your comments by email, be sure to include in your email (i) your full legal name, (ii) any organizations you represent, and (iii) any economic or professional relationships that would be affected by the application on which you are commenting.

**2. Provide public comment regarding items on the agenda during to the meeting**

If you are accessing the meeting by phone or via Microsoft Teams and you would like to speak during the meeting's public hearing(s), you will be asked to do so during the meeting at the appropriate time, and the applicable time limits will be enforced.
