Richmond City Council convened in Informal Session on Monday, May 9, 2016, in the Council Chamber located on the second floor of City Hall, 900 East Broad Street.

Council President Michelle Mosby called the meeting to order at 4:14 p.m. and presided.

Upon the President's request, Assistant City Clerk Lisa Braxton provided information on the appropriate manner in which the Council Chamber is to be evacuated in the event of an emergency.

Grounds Maintenance Update

Bobby Vincent, Public Works deputy director, provided Council with an update regarding the department's grounds maintenance budget, staffing and responsibilities as well as a potential strategy to resolve major maintenance issues. A copy of the presentation has been filed.

John Buturla, interim deputy chief administrative officer – Operations, and Emmanuel Adediran, Public Works director, were also available to answer questions.

Councilor Parker Agelasto arrived at 4:27 p.m. and was seated.

Councilor Parker Agelasto suggested collaborative efforts with the Department of Parks, Recreation and Community Facilities and the Virginia Department of Transportation to assist with addressing the current grounds maintenance backlog.

Councilor Charles Samuels arrived at 4:34 p.m. and was seated.

Councilor Ellen Robertson stated that citizens should be informed of the city's existing grounds and roads maintenance issues and suggested that city administration issue a press release.

Ms. Robertson also suggested that there be a line item in future budgets for contractual grounds maintenance employees.

Mr. Buturla informed Council that the city would have to compensate the Justice Center in order to utilize clients for manual labor; he also stated that inmates are not as reliable.

Due to current overgrown grounds conditions of roundabouts, Councilor Ellen Robertson stated that there needs to be pre-condition maintenance agreements before installing any more roundabouts, since they are not being maintained and are now eyesores in the community.

GRTC Pulse: Bus Rapid Transit (BRT) Project Update

Amy Inman, Economic and Community Development multi-modal transportation senior administrator, provided Council with an update of the bus rapid transit project which included information regarding the design-build procurement process, budgetary details, project timeline and community engagement efforts. A copy of the presentation has been filed.

Carrie Rose Pace, GRTC communication director, was also available to answer questions regarding the BRT project.

Consideration of Boards and Commissions Appointments

Boards and Commissions Administrator Alexander Rawles reviewed applications for the Richmond Redevelopment and Housing Authority vacancy. A copy of the information has been filed.

It was the consensus of Council to appoint Veronica Blount.
