



#### Legislation Text

File #: RES. 2022-R025, Version: 1

To express the City Council's support for highly prioritizing appropriations for the construction of combined sewer system plan projects by July 1, 2035, to improve water quality in the James River in a financially sustainable manner.

WHEREAS, the water quality of the James River is vital to the City's environmental and public health, recreation,

tourism, and economy; and

WHEREAS, the City's combined sewer system, hereinafter referred to as the "CSS," built in the late 1800s, carries

both storm water and sanitary sewer water to the City wastewater treatment plant from approximately 19 square miles

#### Richmond on track with combined sewer overflow cleanup

Richmond's 34-year effort to make sure heavy rains don't overwhelm its sewers and start carrying sewage into the James River has cut such storm and wastewater overflows by more than 3 billion gallons a year.

But that \$300 million-worth of work hasn't finished the job, and the city's Department of Public Utilities says what's still to be done will cost more than \$1.3 billion.

And that, DPU says, is a bill residents can't cover through the fees they're charged on their water bills.

Recent rate increases mean they've already kicked in \$150 million for the work that's still be to done, DPU said in a report to the General Assembly.

Last year's \$50 million from the state, and this year's \$100 million appropriation of American Rescue Plan Act funds, which will be matched by equal amount from the city, will keep a set of General Assembly imposed cleanup goals on track.

In accordance with Virginia Senate Bill 1064 (Acts of Assembly Chapter 634, 2020), the City of Richmond is pleased to submit this report on the efforts it has undertaken to address the Interim and Final Plans for its combined sewer system. This report demonstrates that the City will meet the obligations the General Assembly intended, and in doing so, will provide central Virginia with cost-effective engineered solutions that will further protect and enhance the environment, and, in particular, the vitally important James River.

The City is conducting ongoing operation and maintenance enhancements, implementing projects identified in the Interim Plan, and developing the Final Plan as required by SB 1064. These activities are taking place simultaneously, requiring the City to apply tremendous resources of both funding and staff. As the City of Richmond advances these major projects in the face of workforce issues and logistical and supply chain challenges, we are, at the same time, capturing efficiencies to ensure there is a significant and clear benefit to the environment and the lames River


"1. An independent rate consultant report that includes schedules and other material designed to demonstrate compliance with the above funding and spending criteria. At a minimum, the independent rate consultant's report will include:

- A schedule of sewer rates and charges in effect during the year and an explanation of any changes in the sewer rates and charges during the year;
- A schedule that calculates the current year annual sewer bill for a residential customer with a 7 ccf average monthly sewer use and the percentage of such bill to median household income in the City;
- A schedule detailing sewer related revenues, operation and maintenance expenses, net revenues, debt service, reserve funds and the sewer debt service coverage ratio for the previous year;
- d. A schedule detailing amounts borrowed, grants, and other sources of capital funds, and the amount of capital funds obligated for water quality projects during the previous year; and,


