

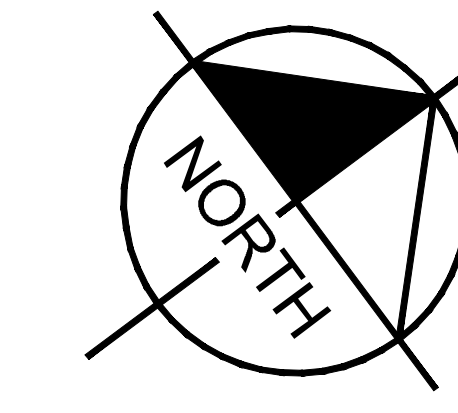
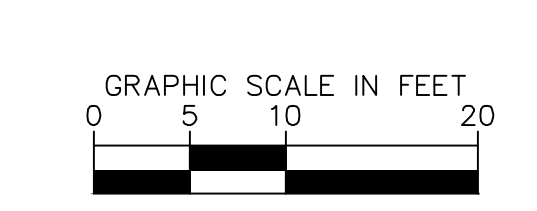


**Mixing Zone**



# PROTOPATH CORRIDOR

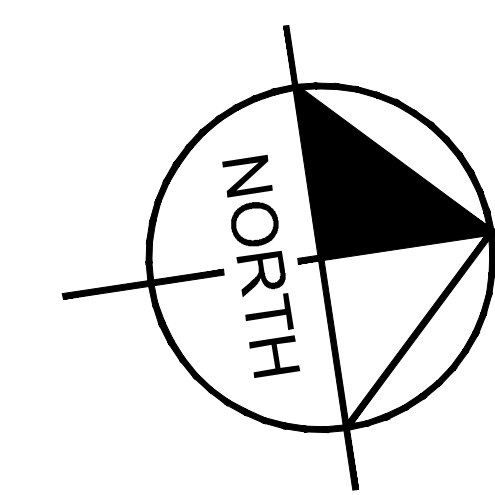
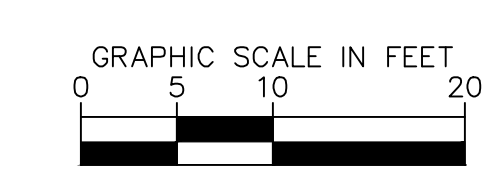
