## THE CITY OF RICHMOND HEREBY ORDAINS:

§ 1. That § 6 of ARTICLE III of Ordinance No. 84-284-253, adopted November 19, 1984, be and is hereby amended and reordained as follows:

§ 6. The City Attorney shall receive a salary of [~~\$64,800~~] \$70,000 per annum.

§ 2. That Ordinance No. 85-66-66, adopted March 25, 1985, adding § 6.1 in Article III of the pay plan ordinance, Ordinance No. 84-284-253, adopted November 19, 1984, as follows, be and is hereby repealed:

"§ 6.1. The Acting City Attorney for the City of Richmond shall receive a salary of \$64,800.00 per annum."

§ 3. This ordinance shall be in force and effective as of November 11, 1985.
