Everyone agrees:

**TRANSPARENCY AND PRIVACY
ARE BOTH IMPORTANT**

The goal of amending City Code 12-16 is to **preserve public access** to meaningful spending information while ensuring the system is **practical, accurate, and compliant with privacy laws.**

HOW WE GOT HERE

2015	Ordinance passed requiring publication of all payments.
2019	The City stopped publishing the payment register due to concerns over data integrity and resource constraints.
2024	The prior administration took down the databases because it was not confident that the published information complied with privacy laws.
2025	The Avula Administration identified that this was a problem that needed to be fixed.
2026	The Administration introduced an ordinance to amend City Code Section 12-16.

Implementation of *City Code §12-16* has been **challenging** for many reasons.



The original ordinance is far broader than other localities and requires a labor-intensive manual redaction process.

Being overly-broad led to resource-intensive, manual redaction processes to comply with privacy laws and confidentiality requirements.

Many contributors across our teams have worked for months to chart a workable path forward.

HOW THE ORDINANCE IS CHANGING

Register of **all payments** made by the City



Register of payments made by the City to **vendors** and **employee reimbursements**

WHAT WILL BE PUBLIC

- ✓ Name of vendor or employee being reimbursed
- ✓ Department issuing payment
- ✓ Amount paid
- ✓ Cost Center

WHAT WILL BE PROTECTED

- ✗ Individual assistance payments
- ✗ Refunds / tax disbursements
- ✗ Personally identifiable or confidential information

The register will no longer include individual payments (e.g., refunds, assistance).

HOW THE ORDINANCE IS CHANGING

Updates City Code § 12-16 to move from:

Register of *all* payments made by the City → Register of payments to vendors and employee reimbursements

The City will now publish:

Payments to vendors for goods and services and payments to employees to reimburse them for operational expenses

The register will no longer include:

Individual payments (tax and payment refunds, financial assistance, garnishments)

WHY THIS MATTERS

Focuses on how taxpayer dollars are spent and makes it easier to identify spending patterns

Closes the gap between policy intent and day-to-day implementation

- Preserves transparency about spending by clearly identifying vendors and reimbursements
- Decreases the need for resource-intensive manual redaction of information that is subject to privacy laws, freeing up City employees' time to focus on delivery of critical services

Aligns with best practices

Matches approaches used in Henrico County, Chesterfield County and Fairfax County, but **goes one step further** by disclosing employee reimbursements

Protects personal information and ensures legal compliance

- Prevents disclosure of sensitive data (e.g., benefits payments)
- Virginia FOIA + state/federal privacy laws
