PURPOSE: To amend Ord. No. 2023-071, adopted May 8, 2023, which adopted the Fiscal Year 2023-2024 General Fund Budget and made appropriations pursuant thereto, by increasing General Fund revenues by the ten percent special purpose reserve from the FY 2023 surplus, per the City's fund balance policy, and appropriating such amount to a new Non-Departmental Budget line-item titled HumanKind for the purpose of providing additional family crisis funding.

BACKGROUND: Per the City's Fund Balance Policy, up to ten percent of any year surplus may be assigned for a special purpose reserve. Special purpose reserves must be only for one-time, non-recurring purposes and may not be for an installment or phase of a multi-installment or multi-phase project. As part of the FY 2023 year-end surplus, the ten percent special purpose reserve was set aside for additional family crisis funding. The Administration has identified HumanKind as the organization to continue this effort.

Dear Honorable Members of Richmond City Council:

As you are aware, my Administration continues to work diligently to address the unmet needs of our residents. This is evidenced through the daily efforts of our Human Services portfolio, and their continuous collaboration with partner organizations, such as HumanKind who has become our fiscal agent for the Family Crisis Fund.

Over the past several months, HumanKind has supported approximately 500 Richmond residents by providing emergency financial assistance for needs related to housing, utilities, medical, and auto repairs. We understand that financial burdens are unique, and each of these families has received varying amounts that do not exceed \$2,500 that cover eligible expenses.

To ensure we do not have a gap in funding for residents accessing these funds, I will be introducing an ordinance to City Council proposing the utilization of my discretionary 10% of the Fiscal Year 2023 surplus to provide additional dollars to the Family Crisis Fund, which is approximately \$800,000.¹

We thank you for your continued collaboration in supporting this effort.
