

This Resolution request is to appoint Paul Van Lenten as Council Budget Analyst to the Richmond City Council, Office of the Council Chief of Staff.

**BACKGROUND**

This O&R is requesting appointment of Paul Van Lenten as Council Budget Analyst with the Richmond City Council, Office of the Council Chief of Staff.

This request is in accordance with Richmond City Code § 2-32, which states, (a) "The City Council may provide for the appointment of a Council Budget Analyst to assist the Council with the analysis of current and proposed policies and legislation that affect the City's budgets. The Council Budget Analyst shall be appointed by the City Council for an indefinite term and shall be a member of the unclassified service".

Mr. Van Lenten's start date of employment was January 30, 2023, therefore the effective date for Council appointment is January 30, 2023. The O&R requested date of introduction is February 13, 2023.
