To authorize Summer Breeze to hold concert events in Monroe Park on Saturday, June 20, 1987; Sunday, July 26, 1987; Sunday, August 9, 1987; and Sunday, September 13, 1987, such concert events may include sale of food, arts and craft items, and alcoholic beverages (beer only), with the sale of beer to end one hour prior to conclusion of the concerts and the concerts to end by dark.

THE CITY OF RICHMOND HEREBY ORDAINS:

§ 1. The provisions of Article VIII of Chapter 9 of the Code of the City of Richmond, 1985, concerning sale of merchandise in the public parks of the City of Richmond, and any other applicable provisions of law of the City to the contrary notwithstanding, Summer Breeze may hold concert events in Monroe Park on Saturday, June 20, 1987; Sunday, July 26, 1987; Sunday, August 9, 1987; and Sunday, September 13, 1987, such concert events may include sale of food, arts and craft items, and alcoholic beverages (beer only), with the sale of beer to end one hour prior to conclusion of the concerts and the concerts to end by dark. Summer Breeze shall comply with any laws or regulations of the City requiring the purchase of licenses, concerning security

(arranged through the Richmond Bureau of Police and in compliance with its instructions and directions), sanitation, and hours of operation and shall also obtain general liability insurance in an amount of \$1,000,000 in which the City of Richmond shall be named as an insured. Prior approval of the Director of Recreation and Parks must have been obtained as a requisite for any performance, that is acts to be staged or entertainment to be offered and provided.

§ 2. This ordinance shall be in force and effect on Saturday, June 20, 1987; Sunday, July 26, 1987; Sunday, August 9, 1987; and Sunday, September 13, 1987.
