

ORDINANCE/RESOLUTION SUMMARY

The patron is requesting a resolution to amend which Council members serve on Council's Standing Committees and the various boards, commissions, and other collegial bodies.

BACKGROUND

This is a request for a Resolution to change and add additional assignments to Council Standing Committees that designate which Council members shall serve on the Council's Standing Committees and the various boards and commissions. Res. No. 2021-R004, adopted Jan. 4, 2021 designates Council Standing Committee assignments for terms that commenced January 4, 2021 and expires on December 31, 2022.

This request is to add additional Council Standing Committee assignments and to change a previous assignment. The changes are as follows:

- Add President Cynthia Newbille as an alternate for the Metropolitan Richmond Air Quality Committee.
- Remove the previously named alternate Councilmember Kristen Larson for the Richmond Area Metropolitan Planning Organization. A replacement will be identified and submitted at a later time.
- Remove Councilmember Kristen Larson and Add Councilmember Ann Lambert to the Richmond Regional Planning District Commission as a Regular member.
- Add Vice President Ellen Robertson and Councilmember Michael Jones as the two alternates for the Richmond Regional Planning District Commission.
