#### Call to Order

Council President Cynthia Newbille called the meeting to order at 6:17 p.m. and presided.

#### **Public Comment**

CD.2025.180 June 2, 2025 Public Comment Period Speakers List

Melvin Jones addressed Council regarding the birthday celebration of Maggie L. Walker and asked that each Councilmember sign a birthday card to hallmark the occasion.

Carol Adams, Engine Company No. 9 and Associates, Inc., addressed Council and stated the importance of continuing to tell the story of the city's first black firefighters so that their legacy will never be forgotten. Willam Fuller, James Chambers, Cecil Dumas, Willam Harper and Donald Houston, veterans of the Richmond Fire Department, introduced themselves and thanked Council for its support.

Andre Tolleris addressed Council and stated that clean, safe drinking water is a basic public health standard and expressed concerns about decades of infrastructure neglect. Mr. Tolleris also stated that the Department of Public Utilities has become synonymous with dysfunction and requested that Council fix recurring water issues immediately.

Danielle Smith addressed Council and expressed support for implementing a proactive rental inspection program. Ms. Smith shared personal experience with toxic black mold in military housing as a child, and stated her professional background in housing policy. Ms. Smith requested that Council keep the anticipated rental inspection ordinance in mind as it has potential to make housing safer for tenant families.

William Ryan, Richmond Democratic Socialists of America member, addressed Council and advocated for the rental inspection ordinance on grounds that it would enable tenants to assert their rights to safe, healthy, and dignified housing without fear of reprisal from landlords. Mr. Ryan also stated that an enforcement regime could generate revenue for the city.

## **Public Hearing**

Latrice Gregory, city contractor custodian, addressed Council in opposition of Res. No. 2025-R019, and stated her gratitude for Council's recognition of the importance of raising wages for workers. Ms. Gregory stated that despite working hard, her paycheck doesn't cover basic needs. Ms. Gregory expressed disappointment that instead of moving forward with wage increases in this year's budget, Council decided to turn it into a study. Ms. Gregory requested that Council pass a living wage ordinance for city contractor workers this summer.

There was no discussion, and the Consent Agenda was unanimously adopted.

## The Regular Agenda

#### The following resolution was considered:

Councilor Stephanie Lynch stated that Council's support of the proposed resolution is a signal and endorsement of a policy that will require political will and motivation to keep it as a priority. Councilor Lynch noted that legislation passed in the 2024 General Assembly allows placement of photo speed cameras within 1,000 feet of school zones where traffic fatalities have occurred.

## **Public Hearing**

Momin Khan addressed Council in support of the resolution and stated that without seeing a resolution such as the proposed, it is unclear what the city's intention is regarding intersection safety. Mr. Khan further stated that striking the resolution would lose confidence in Council's goal for Vision Zero.

Councilor Nicole Jones stated that while Council is not in denial about traffic and pedestrian safety issues, the administration has already provided the requested study data. Councilor Jones expressed support for the work but emphasized the need for an equity analysis to ensure cameras are not just placed without consideration of equity impacts across all districts.

Councilor Ellen Robertson stated that the Land Use, Housing and Transportation Standing Committee wanted to ensure the study was inclusive and provided information about high priority areas rather than identifying just one specific location. Councilor Robertson noted that city staff have answered questions about cost, revenue generation, and administration, but suggested the entire body needs to review the complete report.

Councilor Reva Trammell shared recent examples of speeding incidents on Richmond Highway, including a truck that flipped over and a crash that caused extensive property damage to a hotel. Councilor Trammell emphasized the urgent need for tools to help police slow down traffic.

Councilor Jones asked about the effectiveness of current cameras and whether they are reducing traffic or helping with enforcement.

There was no additional discussion, and Councilor Robertson made a motion to continue Res. No. 2024-R041 to the June 9, 2025, Council meeting, pending amendments to address the concerns raised by members and remove specific location prioritization.

The motion was seconded and unanimously approved.

#### The following ordinance was considered:

**29.** ORD. To amend ch. 26 of the City Code by adding therein a new art. XIX, consisting of §§ 26-1288-26-1292, for the purpose of establishing a

disposable plastic bag tax.

Patrons: Mayor Avula

Laura Thomas, Director of the Office of Sustainability, addressed Council and stated that the ordinance would implement a plastic bag fee across the city for grocers, drug stores, and convenience stores when distributing plastic bags, imposing a five-cent fee per bag. Director Thomas stated that revenues would be four cents per bag to the city and one cent per bag to the retailer. Ms. Thomas further stated this is an effort to reduce chronic litter, reduce impact on stormwater and water infrastructure, reduce capital maintenance costs, and improve environmental quality. She also stated that if approved, this would become effective January 1, 2026, giving a six-month window for outreach and education.

## Public Hearing

Steve Marzolf, Clean City Commission chair, addressed Council and stated that the Clean City Commission fully supports this ordinance.

Ashley Coles, Clean City Commission 6th District member, addressed Council via Microsoft Teams and expressed support for the ordinance.

Councilor Ellen Robertson asked whether this would be regional or just in Richmond, how much revenue is expected to be generated, and whether there are other options where the cost is not passed on to consumers, but retailers would be charged with using alternatives to plastic bags.

Ms. Thomas responded that this is specifically for Richmond, though the city would like regional collaboration. Director Thomas stated that Richmond would become the 11th municipality in the state to implement the tax. Ms. Thomas further stated that in year one, revenue is anticipated to be approximately \$400,000, but in subsequent years there would be a reduction in plastic bag usage with anticipated revenue of \$100,000 to \$150,000. She also stated that retailers can choose to pass the fee on or absorb it themselves.

Councilor Robertson requested a list of businesses subject to collecting the proposed tax.

Councilor Reva Trammell stated opposition to the ordinance due to concerns from seniors about the cost impact, especially for those on fixed incomes. Ms. Trammell stated that seniors are concerned about additional fees and referenced previous fee increases that have grown over time.

Vice President Katherine Jordan asked about delivery services and outreach to seniors for reusable bags.

Ms. Thomas stated that food retailers are not included in this ordinance, so food delivery would not be affected. She also stated commitment to working with Council to identify groups for reusable bag distribution.

Councilor Nicole Jones expressed some support for the ordinance due to issues with singleuse plastics clogging drains and causing infrastructure problems, while acknowledging the need to provide alternatives for residents.

Councilor Kenya Gibson stated that the city is committed to using operational dollars from the Office of Sustainability for reusable bags for SNAP and WIC recipients, and using additional operational funds for broader distribution to seniors and others.

Councilor Andrew Breton expressed support, noting that flat taxes can have regressive impacts but that taxing something the city wants less of is appropriate. Mr. Breton stated that pollution and litter also have inequitable impacts.

Councilor Stephanie Lynch stated that she had evolved from opposition to support after participating in neighborhood cleanups and seeing plastic bag litter throughout the environment.

Councilor Ellen Robertson expressed concerns about the regressive nature of the tax and its impact on low-income communities, particularly those without access to quality grocery stores. Ms. Robertson stated opposition due to the inequitable burden on lowest income families.

There was no additional discussion, and Ord. No. 2025-099 was adopted: Ayes 6, Breton, Gibson, Jones, Robertson, Lynch, Trammell, Abubaker, Jordan, Newbille. Noes 2, Robertson, Trammell. Abstentions 1, Jones.
