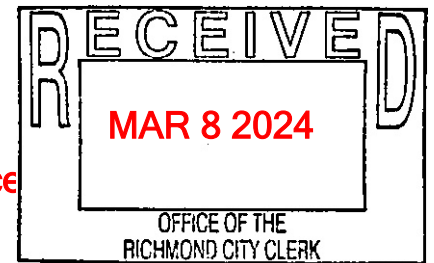

Fifteen (15) members appointed by Council,

The Council shall appoint 15 members. Of the 15 members appointed by the Council, one member from each City Council district who resides or has a principal place of employment in such district shall be appointed, and five members shall be at-large corporate or community representatives, **who may be nominated by the Commission**, and, notwithstanding the provisions of section 2-768 to the contrary, **shall not be subject to any requirement that they maintain a residence or principal place of employment in the city.**

The **Mayor shall appoint 2 members** who reside or have a principal place of employment in the city in accordance with the provisions of section 2-768.

The Director of Public Works or the designee thereof shall serve as an ex officio member.

However, if a member who resides or has a principal place of employment in a Council district has not been identified and appointed within 180 days from the date of a vacancy, the Council, with the approval of the member of the Council member representing the Council district for which a vacancy has occurred, may appoint any person who resides or has a principal place of employment in the city to fill such vacancy. Members who are appointed to fill vacancies or unexpired terms may serve immediately upon appointment and qualification.
