## a) APPLICATION SUMMARY:

The City of Richmond, Virginia and its project partners to include, CARITAS – The Healing Place, The McShin Foundation, Virginia Commonwealth University (VCU) Rams In Recovery Program and REAL LIFE Community Center, make up the Richmond Area Healthy Futures (RAHF) AmeriCorps Project, a coalition approach to help address the intensifying Opioid Crisis by expanding opioid and prescription drug abuse prevention and recovery services.

The program will enroll 14 AmeriCorps members who will be assigned to project partner sites to provide peer recovery support services, community educational outreach and addiction prevention activities. By the end of the service year, AmeriCorps members will have 1) provided prevention and recovery coaching services to 525 unduplicated individuals with 60% demonstrating improvements through active program engagement; and 2) community outreach activities for 2,000 unduplicated individuals to educate, promote wellness and provide resources with 60% reporting increased knowledge.

Funds will be used to pay stipends for AmeriCorps members and other supportive services such as health care, training, AmeriCorps gear and staff costs.
