Project Description	<p>Shakirah Jones of Virginia Community Voice is seeking approval to install two murals on City streets in the Oak Grove neighborhood. The sites are the intersections of Davee and Ruffin Roads by T.B. Smith Community Center, and East 22<sup>nd</sup> Street and Gordon Avenue by Oak Grove Playground.</p> <p>VACV surveyed the community on locations for the project and designs and has received support from residents for the intended street murals. The aim of the street art, titled <i>Art for Safer Streets</i>, is to slow down traffic at these intersections, providing safer pedestrian access to T.B. Smith Community Center and Oak Grove Playground. The street murals will also serve to enhance community-building and placemaking in the neighborhood.</p> <p>The mural designs are by artist Hamilton Glass. The artist will adhere to guidelines outlined in the Manual on Uniform Traffic Control Devices, using anti-slip paint and selecting paint colors that align with the requirements outlined there.</p>

## RATIONALE FOR PLACING ON PUBLIC PROPERTY

The street mural installations outside T.B. Smith Community Center and Oak Grove Playground will slow down vehicular traffic, increase pedestrian safety, and enhance a sense of community around busy gathering sites that provide integral amenities to the children and families of the surrounding neighborhoods. The street murals, which feature the word *unity* surrounded by outstretched hands, reflect Richmond's core values and serve as a reminder of the city's commitment to inclusivity and community support.

## MAINTENANCE

The intersection murals will be painted with anti-slip paint for asphalt art that typically lasts last 2-5 years. Depending on the traffic volume of the street, there is a possibility that the ground mural may need to be touched up during that time. VACV plan to raise funds of approximately \$2,000 for the maintenance of this mural in the next 2-5 years.

## ARTIST BIO

Hamilton Glass started his art career as an architect, and after working in the field for seven years discovered his true passion was painting. His paintings, however, are reminiscent of his past as an architect through technique and style. He often utilizes geometric shapes, line, and color to create bold, graphic murals that work with the existing architecture or landscape to create site-specific works of art. Glass is honored to be a frequent collaborator with organizations who are focused on community growth and outreach. This part of his practice offers him the opportunity to give back to the community through his art and is a huge inspiration in itself.

Glass is a founder of *Mending Walls*, whose mission is to advance social justice by connecting community members from different backgrounds in conversation to foster empathy, understanding, and healing using art as a major vehicle. *Mending Walls* was featured in an Emmy award-winning documentary on PBS. Glass has completed street murals on City property in the past, including street murals for the Bon Secours Richmond Community Hospital as part of its *Community Today, Community Tomorrow: Pathway to Wellness in the East End* strategy.

#### DONOR INFORMATION CHECKLIST

Anyone wishing to donate art for public display to the City of Richmond must follow the City's policies and procedures for "Gifts of Works of Art." The gift will be reviewed in accordance with uniform criteria used for all art in the City's Public Art Collection. This criteria includes:

- 1) Artistic merit and context in the City's art collection
- 2) Site appropriateness
- 3) Fabrication, handling, and installation
- 4) Oversight responsibility
- 5) City liability and maintenance requirements
- 6) Community endorsement
- 7) Budget and guarantee of funding source
- 8) Educational, cultural, and historical value; and contribution to the identity of a neighborhood or district

All art offered to any agency, department or office of the City shall be referred to the Public Art Commission (PAC) for consideration.

For art valued at less than \$2000, the PAC will review the work according to the criteria listed above and make a recommendation to the Planning Commission for final approval.

For art valued above \$2000, the PAC will appoint a "Gift Review Team" (GRT) to review the art according to that same criteria. The GRT shall consist of:

- 1) a representative of the community,
- 2) a representative of the City's user agency responsible for the artwork's care, placement or disposition, and
- 3) at least one member of the PAC.

The GRT will prepare a report for the full PAC who in turn will forward their recommendation to the Planning Commission. Following their assessment, a final recommendation will be presented to City Council for a vote if the value of the artwork is over \$25,000. The Office of the Chief Administrative Officer will inform the donor of the art's final acceptance or rejection.




