THE CITY OF RICHMOND HEREBY ORDAINS:

§ 1. That the sum of \$50,000 is hereby transferred from the unencumbered balance of funds in "Reserve for Contingencies", appropriated in the General Fund Budget and Appropriation Ordinance for the fiscal year 1986-1987 (Ordinance No. 86-118-142, adopted May 28, 1986) to the Appropriation, Non-Departmental, Payments to Other Governmental Agencies, for the City's pro rata share in funding Phase I of a regional port study to be made under the supervision of "The Metropolitan Foundation" (General Fund Budget, pages 33-1 and 33-2), such transfer having been recommended by the City Manager and the Director of Finance having certified that there is a sum not heretofore allotted

for a specific purpose in the appropriation made to Reserve for Contingencies sufficient to meet this transfer of appropriation.

§ 2. This ordinance shall be in force and effect upon adoption.

I recommend that this transfer in the amount of \$50,000 be made to the Appropriation, Non-Departmental, Payments to Other Governmental Agencies.
