

AN ORDINANCE No. 86-176-161

ADOPTED JUN 9 1986

To amend and reordain Section 7-58 of the Code of the City of Richmond, 1985, concerning the fee imposed and to be collected for the use of the first market area, to impose fees of ten dollars per day for parking spaces for trucks weighing in excess of one and one-half tons and not exceeding twenty feet in length and of twenty dollars per day of trucks of greater than twenty feet in length.

1. THE CITY OF RICHMOND HEREBY ORDAINS:
2. § 1. That Section 7-58 of the Code of the City of
3. Richmond, 1985, be and is amended and reordained as follows:
4. Sec. 7-58. Fee for using first market area.
5. The fees for use of the first market area shall be
6. based upon the size of the farmer's vehicle (when appli-
7. cable) and upon the space which the farmer is authorized by
8. the market superintendent to use and shall be as follows:
9. (1) The thirty-two (32) stalls having truck spaces
10. in the open-air shed in the block between Main
11. and Franklin Streets will be limited to trucks
12. of not greater than one and one-half ton

1. capacity and not exceeding twenty (20) feet in
2. length. The fees for these spaces will be four
3. dollars (\$4.00) per day or portion thereof.

4. (2) The fifty-two (52) booths having no adjacent
5. vehicle space in the open-air shed in the
6. block between Main and Franklin Streets will be
7. leased for three dollars (\$3.00) per day or
8. portion thereof.

9. (3) For the privilege of parking a truck, the gross
10. vehicle weight of which truck is in excess of
11. one and one-half ton, but the length of such
12. truck does not exceed twenty (20) feet, within
13. the first market area at a space (specifically
14. excluding the stalls referred to in (1) supra,
15. which said stalls are not designed for and
16. cannot accommodate such trucks) to be assigned
17. for such truck by the market superintendent, or
18. his designee, there shall be imposed a fee of
19. ten dollars (\$10.00) per day, which fee shall
20. be payable in advance.

21. (4) For the privilege of parking any truck, the
22. length of which exceeds twenty (20) feet, with-
23. in the first market area at a space (specifi-
24. cally excluding the stalls referred to in (1)

1. supra, which said stalls are not designed for
2. and cannot accommodate such trucks) to be
3. assigned for such truck by the market superin-
4. tendent, or his designee, there shall be
5. imposed a fee of twenty dollars (\$20.00)
6. per day, which fee shall be payable in
7. advance.

8. Notwithstanding the above, a discount of fifty
9. cents (\$0.50) per day shall be applied to the above rates
10. when a space is leased for a period of one month or longer.
