Call to Order

Council President Cynthia Newbille called the meeting to order at 6:21 p.m., and presided.

Citizen Comment

[CD.2022.277](#) July 25, 2022 Citizen Comment Period Speakers List

Reverend Gwen Hedgepeth addressed Council and stated her concerns regarding a proposed emergency homeless shelter located in her neighborhood. Reverend Hedgepeth informed Council that she was in favor of supporting the homeless population, but she noted that she did not believe it was fair that emergency shelters were only located in two Council Voter Districts.

Charles Pool addressed Council and stated his gratitude that RES. 2022-R033, which designated Oregon Hill as a residential neighborhood, was adopted by Council. Mr. Pool informed Council he was concerned that city staff were not adhering to Council's action regarding RES. 2022-R033 when reviewing future land use in Oregon Hill. Mr. Pool requested that Council ensure that city staff adhere to RES. 2022-R033.

Jesse Walker, Westover South and Woods Civic Association President, addressed Council and stated his concerns with a homeless shelter being located in his neighborhood. Mr. Walker stated that it was a civic duty to support the homeless population, but he requested that the city address the issue in a fair way. Mr. Walker informed Council that he had signatures from residents that were also concerned about the lack of information regarding the shelter.

A copy of all material provided has been filed.

Councilor Michael Jones stated his appreciation for Mr. Walker's comments, and he also stated that he was concerned that homeless and emergency shelters were primarily located in the city's Southside. Councilor Jones further stated that he wanted to see other areas of the city share in the responsibility of providing services to the city's homeless population.

Councilor Stephanie Lynch stated that she supported an emergency homeless shelter being established in the 5th Voter District to provide emergency services to the city's homeless population.

President Cynthia Newbille stated her appreciation for citizens that provided comments regarding the homeless shelter, and she requested that city administration take appropriate action regarding the concerns stated. President Newbille also requested that city administration take necessary action to provide a healthy and safe environment for the city's homeless population.

Councilwoman Reva Trammell stated her concerns that the city's Southside was the primary location for emergency homeless shelters in the city. Councilwoman Trammell also stated her concerns with the lack of affordable housing options in the city.

Councilwoman Trammell requested that the city demolish blighted properties in order to build more affordable housing options.

Councilor Ann-Frances Lambert stated that she was in support of additional areas of the city providing emergency homeless shelter services.

Clifford Chambliss, III addressed Council regarding the Reconnect Jackson Ward project. Mr. Chambliss stated it was important that the city address the project in an equitable way due to the city's history of discriminatory action within the area related to the city's Black population. Mr. Chambliss also requested that potential reparations be reviewed that could address the negative impacts inflicted on the city's Black population.

Vice President Ellen Robertson stated her appreciation for the comments provided by Mr. Chambliss, and she informed Council that conversations were taking place to address the issues raised by Mr. Chambliss.

Ms. Esparza also stated that the applicant did not include the Deerbourne Civic Association in discussions regarding the rezoning. Ms. Esparza requested that Council continue consideration of the proposed ordinance.

Jeff Geiger, attorney representing the ORD. 2022-207 applicant, informed Council that outreach was conducted regarding the proposed rezoning. Mr. Geiger stated that the ordinance was a small procedural step related to Council's prior approval of the rezoning.

Councilwoman Reva Trammell stated her appreciation and support for the ORD. 2022-207 applicant.

Ryan Klein spoke in support of ORD. 2022-105, and he stated that the proposed speed tables would increase safety, reduce speeding, and calm traffic on Moss Side Avenue.

Max Hepp-Buchanan spoke in support of ORD. 2022-105, and he stated his appreciation for Council listening to the concerns of residents on Moss Side Avenue. Mr. Hepp-Buchanan also stated that the speed tables would make the area safer for families with children.

Jessica Rexroat spoke in support of ORD. 2022-105 and stated that the proposed ordinance would decrease dangerous driving on Moss Side Avenue. Jessica Rexroat also stated her appreciation for the process of bringing the ordinance before Council for consideration.

Jane Braden spoke in support of ORD. 2022-105 and stated that the ordinance would help decrease reckless driving on Moss Side Avenue. Ms. Braden also stated that the ordinance would make it safer for residents and young families to cross the street.

Councilor Ann-Frances Lambert stated her appreciation for residents that were involved with ORD. 2022-105 and the request for speed tables on Moss Side Avenue.

Sandra Antoine, NAACP Richmond Chapter representative, spoke in support of ORD. 2022-221 and stated that the NAACP Richmond Chapter supported collective bargaining for city employees.

Sean Kasar, Democratic Socialists of America Richmond Chapter member, stated that the Democratic Socialists of America Richmond Chapter supported the efforts of city employees regarding the ability to collectively bargain. Mr. Kasar also stated that the proposed ordinance was a good first step, but that a labor relations administrator should be hired as soon as possible to begin the collective bargaining process.

Keith Andes, IAFF Local 995 President, spoke in support of ORD. 2022-221, and he stated that IAFF Local 995 looked forward to addressing working conditions and public safety employee issues with city administration.

Bill Pantele, Richmond Coalition of Police representative, spoke in support of ORD. 2022-221 and stated his appreciation for city administration and Council working together to bring the proposed ordinance forward. Mr. Pantele also stated that the improved working environment for city employees would lead to better services being provided to city residents.

Brian Peyton, Teamsters Local 322 President, spoke in support of ORD. 2022-221 and stated that collective bargaining would improve the lives of city employees.

Ben Himmelfarb, city employee, Service Employees International Union (SEIU) 512 member, spoke in support of ORD. 2022-221 and stated his appreciation for SEIU members that worked on the possibility of collective bargaining.

Maurice Black, city employee, spoke in support of ORD. 2022-221 and stated that city administration and city employees needed to continue to work together regarding collective bargaining.

Felicia Boney, city employee, SEIU 512 member, spoke in support of ORD. 2022-221 and stated that the work of collective bargaining was just beginning.

Julius Phillio, city employee, SEIU 512 Member, spoke in support of ORD. 2022-221 and requested that Council adopt the proposed ordinance.

Phil Shepard, city employee, SEIU 512 member, spoke in support of ORD. 2022-221 and stated that the ordinance was just the first step regarding building stronger union representation for city employees. Mr. Shepard requested that a labor relations employee be hired quickly.

Lee Williams, Sierra Club Falls of the James Group Executive Committee member and Advocacy Committee Chair, Green New Deal Virginia Co-Chair, spoke in support of ORD. 2022-221, and she stated that city employees work in extreme and dangerous working conditions due to climate change and that collective bargaining would help improve working conditions for city employees.

Councilor Stephanie Lynch stated that it was a collaborative effort between Council, city employees, and city administration regarding collective bargaining and ORD. 2022-221.

Chief Administrative Officer (CAO) Lincoln Saunders stated that collective bargaining would make the city a desirable destination for employees to work. CAO Saunders requested that Council and city administration cautiously approach collective bargaining moving forward.

Councilor Ann-Frances Lambert stated her appreciation for individuals that worked on drafting ORD. 2022-221 and collective bargaining.

Councilor Kristen Nye stated her appreciation for individuals that provided comments regarding ORD. 2022-221. Councilor Nye also stated that collective bargaining was very important for the city and city employees. Councilor Nye further stated her appreciation for the compromises reached by all parties involved in drafting the proposed ordinance.

Councilor Michael Jones stated that collaboration was key in the drafting of ORD. 2022-221. Councilor Jones also stated that the collaboration amongst involved parties should be an example for how the city can move forward on other important issues within the city.

Councilwoman Reva Trammell stated her appreciation for city workers, city administration, fellow members, and Council staff for the collaborative work regarding ORD. 2022-221 and collective bargaining.

Councilor Andreas Addison stated that the work of city employees, regarding the right to collectively bargain, displayed the desire for a better working environment for city employees. Councilor Addison also stated his appreciation for the collective efforts in the drafting of ORD. 2022-221.

Vice President Ellen Robertson stated her appreciation for the commitment of city employees and union representatives regarding the request to collectively bargain. Vice President Robertson also stated that she hoped collective bargaining would ensure that city employee compensation is adequately addressed during the review of upcoming city budgets.

President Cynthia Newbille stated her appreciation for the collaborative work of union representatives, Council, city administration, and city employees in the drafting of ORD. 2022-221. President Newbille also stated that improved city employee working conditions would lead to better city services being provided to city residents.
