A lifelong resident of the historic Church Hill Neighborhood in the Richmond East End 7th Voter District, Ms. Alicia Charlene Rasin graduated from Richmond Public Schools John F. Kennedy High School and Virginia State University.

A longtime advocate and spokesperson on behalf of anti-crime efforts and crime victims, Ms. Rasin was an important leader and stalwart voice in our community for more than 25 years. During that time, Ms. Rasin provided kindness, comfort and compassion for those suffering the loss of loved ones and helped fight crime and heal neighborhoods facing adversity.

As testament to her dedication, in the mid 1990's Ms. Rasin founded an organization named Citizens Against Crime to help organize efforts to assist residents and law enforcement with reducing crime in Richmond. In 1994, then Mayor Leonidas Young, recognized Ms. Rasin as Richmond Volunteer of the Year and dubbed her a Richmond Ambassador of Compassion.

In America, public and community service is considered to be among the most important and noble work a person can do and, through her outstanding example, Ms. Alicia C. Rasin proved her dedication to and support of the principles and creed written into the founding documents of our great Nation, in that our individual destinies and that of our families, communities, city, state and country include not only the aspiration of our federal constitutional republic but, the time, talent, investment, labor and dedication of all its residents in realizing the fulfillment of its promise.

In order to memorialize her service, on November 9, 2015 Richmond City Council unanimously approved Ordinance No. 2015-231-224 that designates the street block on which Ms. Rasin lived, at 1900 Block of Princess Anne Avenue in Richmond, Virginia, in her honor and directed the official installation of a commemorative sign to be placed thereof.

Whereas, The Honorable Dwight C. Whereas, The safety and wellbeing of all individuals is critical to the foundation of a thriving progressive society and serves as the measure of its viability; and

Whereas. People who may or may not self-identify as transgender, which includes those who are transsexual, crossdressers, or otherwise gender-variant, are too often victims of violence based on bias against people who are transgender; and

Whereas, The creation of a Transgender Day of Remembrance had its beginnings in the city of San Francisco, California in 1999 as a candlelight vigil memorializing the death of Rita Hester whose murder, on November 28, 1998, was understood to have been due to anti-transaender intolerance: and

Whereas, Embracing our individual identities and commonalities as Americans helps to further bring people together and drive the development and progress of society; and

Whereas, Affecting nearly every aspect of our daily lives, computer technology impacts everyone and every sector of our society in helping provide and improve the availability and quality of such critically essential and fundamental things as food, healthcare, clothing, jobs, housing, transportation, public safety, sanitation, clean municipal water and communications; and

Whereas, An importance that cannot be overstated, computer technology plays a leading role in the status, structure and stability of our state, local, national and world economies and in helping establish breakthroughs and innovations for such crucial things as life-saving medicines and renewable energy; and

Whereas, A branch of Engineering, Computer Science has been used to describe the theoretical study and practical use of computerization, including hardware, software, design and information technology; and

Whereas, Computer Science is a field that requires the intelligence, education and training of many people performing many different jobs and roles; and

Whereas, Understanding the vital need to fill these positions, in 2009 the Association for Computing Machinery and public and private sector partners established a Computer Science Education Week to help increase the awareness of the importance of computer science education at all levels; and

Whereas, The week selected was chosen to coincide with the birthday of former U.S. Navy Rear Admiral Grace Brewster Murray Hopper who was born on December 9, 1906 (died January 1, 1992); and

Whereas, Recognized as one of the first women programmers in modern Computer Science, Admiral Hopper is credited with work that helped build the foundation for many advancements in the field; and

Whereas, As a promotional component of the weeklong celebration, in 2013 an "Hour of Code" event was adopted as an activity to help promote Computer Science Education Week; and

Whereas, This year's promotion includes a Star Wars movie theme, which includes and was made possible by the use of Computer Science technology;
