Director's Report

Director Vonck provided an update on the Code Refresh project and shared dates for upcoming meetings.

Consideration of Continuances and Deletions from Agenda

To authorize the special use of the property known as 3618 Hawthorne Avenue for the purpose of a four-unit multifamily dwelling and six single-family attached dwellings, upon certain terms and conditions.

Regular Agenda

8. Annual Presentation on Richmond 300 Master Plan

Marianne Pitts, Senior Deputy Director, gave an annual progress report on the City's Richmond 300 Master Plan.

Ms. Pitts discussed community engagement efforts happening, updated the City Planning Commission on the metrics, and gave an overview of what the team is focusing on.

During the presentation, Commissioner Robertson asked Ms. Pitts for more information about the community involvement with the Gilpin neighborhood.

Ms. Pitts offered to bring additional information specifically on Gilpin and the overall plan for the Jackson Ward neighborhood to the City Planning Commission at a later date.

During discussion about expanding housing opportunities, Commissioner Robertson and Vice Chair Greenfield spoke about the importance of investing in housing development and housing sustainability.

Chair Poole suggested looking at the sections of the City's Capital Improvement Plan that covers funding for housing opportunities.

Commissioner Robertson expressed concerns about how changes in the federal government will impact Richmond residents.

Ms. Pitts clarified that the housing department is looking closely at the metrics that have been collected.

Commissioner Knight and Ms. Pitts discussed funding.

Ms. Pitts gave additional updates on other key "Big Moves" of the City's Richmond 300 Master Plan.

Ms. Pitts and the City Planning Commission discussed how the Master Plan will be updated, action items the Commission is looking for and the timeline for updates.

Director Vonck went through the projected timeline for the Code Refresh process and other updates.

Chair Poole opened a public hearing.

Preston Lloyd, resident of the 5th District and former member of the advisory committee for the Richmond 300 planning process, discussed the difficulty of developing affordable and equitable housing in Richmond. Mr. Lloyd explained that the City needs to invest in infrastructure that supports additional density and amend the Master Plan, specifically the future land use categories, to further support that density.

Commissioner Pinnock, questioned how zoning can be used to support the increase in density.

Ms. Lloyd explained the tangible regulatory impact of zoning. Mr. Lloyd also expressed that the Master Plan can be more aspirational than zoning.

Chair Poole expressed the importance of revisiting the Master Plan.

Upcoming Items

Alyson Oliver, Planning Commission Secretary, gave an overview of items adopted at the February 24, 2025 City Council meeting as well as items to be considered at the next Planning Commission meeting.
