PROJECT LOCATION

Four intersections along the Jefferson Davis Highway Corridor (1) 12th and Bainbridge Street; (2) Minefee Street and Harwood Street; (3) Ruffin Road and Davee Road; and (4) Lynhaven Avenue and Brady Street

PROJECT PURPOSE

RVA Thrives/Virginia Community Voice is working with noted Richmond artist Hamilton Glass and Jefferson Davis Corridor's black, Latino/a, and white youth of the Art, Racial Reconciliation, and Civic Advocacy (ARCA) group in a collaborative program with the mission to deepen relationships across racial and ethnic lines; learn how to advocate for community projects; and design and implement street art.

SUMMARY & RECOMMENDATION

Background: The mission of Virginia Community Voice is to equip neighbors in marginalized communities to realize their vision for their neighborhoods, and prepare institutions to respond effectively. RVA Thrives, a program of Virginia Community Voice, increases neighborhood leadership over decisions affecting Richmond's Jefferson Davis Corridor community. Since 2016, RVA Thrives has *listened* to understand what neighbors along the corridor want to see happen in their community. ARCA is a collaborative program run by RVA Thrives and the Jefferson Davis Highway Corridor's black, Latino/a, and white youth, with a mission to deepen relationships across racial and ethnic lines; learn how to advocate for community projects, and design and implement street art, of which, this project is an example.

Correlation to Public Art Master Plan:

- Involves temporary "commissions" (p 8)
- Encourages community-based involvement in a public art project (p 7 & 8)

Recommendation: Staff recommends approval of this project with the following conditions:

- 1. The petitioner shall be responsible for obtaining and adhering to all necessary permissions and permits for the project as required by the Department of Public Works.
- 2. The petitioner shall be responsible for the cost, maintenance, and installation of the murals.
