PURPOSE: To authorize the Chief Administrative Officer to accept \$381,749 from the Commonwealth of Virginia and to appropriate \$381,749 to the FY2016 General Fund Budget by increasing appropriations to:

- the Sheriff's Office by \$306,070,
- the Treasurer's Office by \$2,622,
- the Commonwealth Attorney's Office by \$57,713, and
- the Finance Department by \$15,344.

This action will amend the FY2016 General Fund Budget (Ord. 2015-73-84) by \$381,749.

REASON: The FY2016 Proposed General Fund Budget did not include a salary increase for Constitutional Officers and their staff as the General Assembly was deliberating on whether to fund salary increases and how much of a salary increase to fund, for state supported, local employees. The Administration indicated during City Council's budget sessions that once the General Assembly adopted the State budget with a salary increase, then it would move forward with requesting City Council to appropriate the additional state revenue to fund the pay increases for these specific departments.

RECOMMENDATION: The Administration recommends adoption of this ordinance.

BACKGROUND: The FY2016 Proposed General Fund budget included a 2% salary increase for city employees with the exception of individuals in sworn positions and those state supported positions reimbursed by the State Compensation Board (Constitutional Offices). The State indicated during the winter of 2014/early 2015 that it was considering pay increases for state employees. However, final General Assembly approval of the State salary increase did not occur until after the Mayor's budget was proposed on March 13, 2015. The State included funds in their budget to support this salary increase effective August of 2015.

State reimbursement funds for the 2% salary increase were not included in the Mayor's Proposed 2016 General Fund Budget due to the State not having made a final decision on the salary increase prior to the Proposed Budget being introduced. Now that the General Assembly has adopted its budget, to include a 2% salary increase, this budget amendment seeks to accept and appropriate the additional State revenue to respective Constitutional departments to fully fund their 2%.

FISCAL IMPACT/COST: This ordinance will amend the FY2015-F2016 general fund budgets of multiple departmental budgets (see attached).

FISCAL IMPLICATIONS: The current year budgets for various general fund departments would change to reflect the funds needed to support the State approved 2% salary increase.

BUDGET AMENDMENT NECESSARY: Yes. An amendment is needed to accept additional funds from the commonwealth and to appropriate such funds.
