PURPOSE: To authorize the Chief Administrative Officer to accept and appropriate grant funds in the amount of \$20,000 from the E. Rhodes and Leona B. Carpenter Foundation of the City of Richmond to help defray the cost of the 61st Annual Festival of Arts at Dogwood Dell.

REASON: The City of Richmond through its Department of Parks, Recreation and Community Facilities (DPRCF) is seeking approval to accept a grant award in the amount of \$20,000 from E. Rhodes and Leona B. Carpenter Foundation of the City of Richmond. The grant will provide additional funding that will help cover Dogwood Dell's Festival of Arts annual operating expenses.

RECOMMENDATION: It is recommended that this funding is appropriated to the Department of Parks, Recreation and Community Facilities FY2019 Special Fund.

BACKGROUND: Dogwood Dell Festival of Arts is a three month outdoor amp-theater venue that provides performance opportunities to local and national artist of diverse cultural backgrounds. This three month festival is free to the public and requires supplementary funding to keep it at the highest level of cultural presentations. This \$20,000 grant is awarded by E. Rhodes and Lenoa B. Carpenter Foundation in recognition of the benefits and value in the quality of service that the City of Richmond, Department of Parks, Recreation and Community Facilities Cultural Arts division provides during their 61st Annual Festival of Arts at the Dogwood Dell.

FISCAL IMPACT/COST: The \$20,000 grant funding will assist in continuing to provide high quality performances for the Festival of Arts at Dogwood Dell.

FISCAL IMPLICATIONS: The acceptance of this award will allow for continued expanded promotion and implementation of high quality programs being provided.
