Vice Chair Andrew Breton asked what the successful Department of Parks, Recreation and Community Facilities activities for the elderly were. He also asked what the city environment changes the elderly requested were, and whether newly built homes would be elderly accessible.

Ms. Houpe stated community events were not elderly specific, however the Senior Day event that is hosted every year was successful. She also stated residents would like sidewalks repaired and that 90 percent of adults would like to age in place, however, home repairs remain a challenge.

Vice Chair Breton asked whether the city had funding for home repairs for the elderly.

Ms. Houpe stated Healthy Homes, Project Homes and Habitat for Humanity offer funding for the elderly in conjunction with the city.
