

I am a Richmond City resident, residing on Brookland Pkwy between Robin Hood Drive and Hermitage, in the area affected by proposed ordinance No. 2023-356. This ordinance would reduce the speed limit from the current 35 mph to 25 mph from Brook Rd to Hermitage. I am writing in enthusiastic support of this ordinance.

The current speed limit of 35 mph is an aberration. The speed limit of Brookland Pkwy east of Brook Road (where it is a four lane median divided street) is 25 mph. But for reasons that are unclear, for the seven blocks from Brook Rd to Hermitage the speed limit increases to 35 mph.

This speed increase is unwarranted and it is dangerous. This winding stretch of Brook Rd, originally developed as four lanes divided by a median, was reduced to one driving lane on each side, plus a parking lane, and, now, a bicycle path- essentially 2.5 lanes on each side (see photos attached). This design squeezes the parking lane perilously close to the cars speeding by at speeds often closer to 45 mph. It is so perilous that people parking their cars often fudge over into the bicycle lane, which is a hazard for the bicyclists.

In addition, because of the winding nature of the road through this area, and the unconventional intersections at Robin Hood and Rennie/Loxley (see photos attached), it is often difficult for drivers to assess the safety of entering the intersections. There have been several accidents at or near Loxley because of this issue.

And in the middle of this stretch of Brookland Pkwy, at Robin Hood, is the Waldorf School zone, which, when activated, reduces the speed limit to 25 mph, which is more often observed in the breach because of the higher default speed limit.

There is nothing inherent in this seven block stretch which demands a higher speed limit; the neighborhood character, the lane design, and the extremely close proximity of the speeding cars to the parking strip, call for a reduced speed limit.

I have attached satellite views to illustrate the situation.

For safety's sake, please approve this ordinance, and reduce the speed limit to a level that the current lane configuration requires.

I am submitting my public comment for ORD 2023-340 regarding the closure of W. 20th St. I am a homeowner in the Belle Heights neighborhood and will be directly affected if 20th street is closed.

As a member of the HOA and full time resident, I have serious concerns for the implications of closing this route. The neighborhood was designed to have that road be an exit for the neighborhood. I bought my townhouse with this agreement with the developer.

If the road is closed, there will be significant traffic rerouting that will affect the safety of the neighborhood, especially when the surrounding land becomes developed. It will cause unprecedented and unsustainable congestion on Manastoh/previous 21st St. There is already a congestion issue at the intersection of Manastoh/Semmes currently, and this will exacerbate it. We have families and kids in the neighborhood-funneling the traffic to Manastoh/21st Street will put pedestrians at risk. It will make it incredibly difficult to head west on Semmes; make Sioux Falls Alley a shortcut (a huge safety concern for residents); threaten pedestrian safety; and worsen our already strained parking situation.

I attended a meeting with an attorney that represents the landowners of the surrounding property's interest and was displeased with their proposed solution(s). They discussed putting another East/West road from the neighborhood to Cowardin. They claim this will improve the neighborhood, and I completely disagree. They have shared that a stoplight at the intersection of Manastoh/Semmes is not feasible, so their solutions do NOT resolve the issues that closing 20th street will create. Additionally, people in Springhill and Woodland Heights neighborhoods also share concerns of the density of development that closing 20th St. will create. Several blocks of residents wish 20th street to remain.

I appreciate the Commission's December 4, 2023 delay of action on ORD 2023-340 until the January 2, 2024 meeting. This delay gave the neighborhoods adjacent to the proposed closure of W 20th St. some time to examine the proposal further, meet with the developer's representative (Preston Lloyd), and speak with members of the Planning Commission, City Council, and staff,

The Springhill Old and Historic District and neighborhood has concluded that vacating the re-establishment of W 20th St from Semmes Ave south to Sioux Falls Alley will be detrimental to the adjacent neighborhoods.

We urge the Planning Commission and City Council to do the following:

- Reject proposed ordinance 2023-340
- Ensure the completion of W 20th St
- Provide safe vehicular and pedestrian passage at the intersection of W 21st St and Semmes Ave

The original plans for developing Belle Heights include completion of W 20th St. The street was also included in materials presented to purchasers of the new townhomes. That portion of the street grid is vital to traffic flow in and out of the Belle Heights neighborhood, *even before* approximately 250 new apartments are built along the 2000 and 1900 blocks of Semmes Ave (south side) plus twenty *senior* apartments on the 1900 block (north side) of Semmes Ave which have already been approved and are underway. The City's Master Plan also calls for completion of the street grid because it helps the interconnectedness of neighborhoods and helps vehicles and pedestrians move freely.

Every Springhill neighbor I spoke with about the proposal was eager to sign the petition communicating our request to require the completion of W 20th Street. Further, many shared their fear when traveling Semmes Ave when needing to turn into and out of the Springhill neighborhood because of uninhibited traffic speeds. Not only is it difficult for vehicles to enter and exit Semmes Ave, but pedestrian crossing is also treacherous. Vehicle speeds make it unsafe for pedestrians to get across to bus stops, other neighborhoods, and businesses. 

# Hello and Happy New Year,

I am submitting a public comment for the ORD. 2023-340 regarding the proposed closure/vacation of the right-of-way of W 20th St. at the intersection of Semmes Ave. My wife and I are homeowners in the Belle Heights neighborhood and will be directly and negatively affected if the right-of-way of W 20th street is closed/vacated based on the sole interest of a single proposed developer of the adjacent vacant lot.

As a member of the Belle Heights HOA and full time resident, there are serious concerns about the implications of closing off the possibility for W 20th St of being a road in the future. It's only a single developer who wants to have the ROW vacated in order for them to make even more money at the expense of neighboring landowners by building a large development on the adjacent undeveloped land without having to worry about the existing street grid. By closing down that section of W 20th St, that will result in nearly all traffic of the future development using W 21st St south of Semmes Ave (A/K/A "Manastoh Rd" in the Belle Heights neighborhood) in order to either: 1) exit onto Semmes Ave to turn Left and head West on Semmes Ave.; AND/OR 2) enter into and travel towards the back of the proposed development.

In short, the section of W 21st St south of Semmes Ave., is not designed (or sufficient) to handle an increase of any more traffic than it currently serves for the Belle Heights neighborhood. It's simply too small of a street and barely serves the current traffic volume of Belle Heights - much less handling more traffic from an adjacent development that is poorly designed to allow for sufficient traffic ingress/egress on its own.

If the ROW at W 20th St is closed, there will be significant detrimental impacts from the resulting oversized development that will negatively affect the safety of the neighborhood. It will cause unsustainable congestion on Manastoh/W 21st St. There is already a congestion issue at the intersection of Manastoh and Semmes currently and any closure of W 20th St would only exacerbate it.

My wife and I are also concerned that by allowing such a large development on the vacant land (which the closure of the ROW of W 20th St would allow), the resulting oversized development will inevitably not have enough parking spaces and there will be spillover of future cars looking to park in the Belle Heights neighborhood - which already has barely enough parking spaces for current residents.

Plus, with many families and children in the neighborhood, any increase of traffic on Manastoh/W 21st St will be a safety issue for pedestrians and bicycle traffic. Having a huge apartment building or other large development adjacent to Belle Heights and W 20th St will hurt pedestrian safety, make it incredibly difficult to exit Belle Heights and head West on Semmes Ave, and threaten to worsen the already strained parking situation.

My wife and I attended a meeting with an attorney that represents the landowners of the adjacent property's interest and we are displeased with a solution they proposed. In fact, we really don't consider it to be a "solution" at all because it doesn't seem to actually solve any of the problems that the closure of W 20th St will create. The proposed developers discussed putting another road from the Belle Heights neighborhood with an exit out to Cowardin Ave. They claim this will improve the neighborhood, and we completely disagree. If W 20th St is closed, there is absolutely no need for a connection to Cowardin Ave, as anyone in the neighborhood can easily head East on Semmes a very short distance to the intersection with Cowardin and turn Right if we ever wanted to head South on Cowardin (or alternatively, head out the back of the Belle Height neighborhood to Perry St and out to Cowardin directly). Practically speaking, there's probably not a single person in the Belle Heights neighborhood that ever has trouble heading South on Cowardin - nor do we need a way to turn Right off of Cowardin and take a winding, S-shaped road into our neighborhood. In summary, it's hard to see how the proposed solution of a connecting road to Cowardin Ave. truly benefits Belle Heights. (Now, if the future developers of the adjacent land want to build their own connection out to Cowardin Ave to serve the purposes of directing traffic to their development from Cowardin, that is their prerogative to pursue)

Additionally, people in the nearby Springhill and Woodland Heights neighborhoods also share concerns with the density of development that closing W 20th St. will create. There are lots of people in the surrounding area who wish W 20th St to remain. Any future development of the adjacent land needs to simply provide sufficient options (like using W 20th St) for ingress/egress on to Semmes Ave as part of the development.

Please consider our opinion in your decision and keep the ROW at W 20th Street open. Thank you for your time and attention.

I live on Wentbridge Road and cross this road several times daily. When I am driving I frequently see cars look like they are going to climb up my bumper when I turn onto Loxley. I often hear horns blown because I slowed down to make the turn.

As a long time resident I wouldn't park on the road until the parking lanes were clearly delineated because I can remember at least three occasions when parked cars were hit because of people speeding around curves. I still have someone pass me in the bike lane about once a month because they are going too fast when I slow down to turn.

Myself and my wife Anna Raby, are writing to you today opposing ORD 2023-340. We own 2001 Old Manchester St, Richmond VA 23225 in the Belle Heights neighborhood. Should this take place, it will only do harm to our neighborhood causing a higher risk of pedestrian injury and create further traffic issues. There have already been numerous deadly crashes outside of our main neighborhood entry on Semmes Ave. A terrible accident happened just yesterday and the cars had to be towed into our entry to clear Semmes Ave. We all are in support for this area to be developed and have it enrich the neighborhood and contribute to the community. This is not this issue, the closing of 20th street with a bigger population and more traffic will cause nothing but harm and more chaos. The proposed cut through to Cowardin is not helpful. This will cause the majority of the traffic needing to get downtown to turn right and then make a u-turn to go in the correct direction. Hull St restricts left hand turns so this is not helpful either.

Please remember the original plan for B-6 business district that was set forth. I understand there can be exceptions but please listen to the people who live here and fully understand the risks involved and the ripple effect this will have with traffic and pedestrian safety in mind. I am a Richmond native having worked in residential property management for 13 years with 8 of those years with Thalhimer overseeing Class A high traffic high-rise properties downtown and now a VA realtor. I understand the benefits and concerns. A true mixed use building that fits the original lot layout would be a true asset to all parties allowing W20th st to open, commercial units on the bottom floor and residential above no higher than 4 stories. Thank you for your time and consideration. Highlighted below are some key points that really need to be honored.

#### **DIVISION 24. - B-6 MIXED-USE BUSINESS DISTRICT**

#### Sec. 30-444.1. - Intent of district.

Pursuant to the general purposes of this chapter, the intent of the B-6 district is to encourage development of mixed land uses consistent with the objectives of the master plan and the downtown plan, and to promote enhancement of the character of development along principal corridors and in other areas. The district regulations are intended to encourage appropriate infill development on undeveloped land, promote adaptive reuse of underutilized buildings or enable redevelopment of properties where continuation of current uses or adaptive reuse is not feasible, depending on the character and needs of particular areas. The district regulations are also intended to safeguard the character of adjoining properties, to maintain existing streetscape character by providing continuity of building setbacks and heights, to enhance public safety and encourage an active pedestrian environment appropriate to the mixed use character of the district by providing for windows in building façades along street frontages, and to promote an environment that is conducive to preservation of important historic, architectural and cultural features that may exist within the district, Finally, the district regulations are intended to ensure adequate accessible parking and safe vehicular and pedestrian circulation, to facilitate a streetscape with minimum setbacks along principal street frontages and to provide for limited interruption by driveways and vehicular traffic across public sidewalk areas along principal street frontages.

### Hello all,

This is in reference to ORD. 2023-340, the closing of W 20th st between Semmes Ave and Sioux Falls. I am a property owner within a block affected by the closing at Sioux Falls and I would like to express my deep concerns with this proposal.

I would like to start out by addressing the line, "Belle Heights Homeowners Association Inc., a Virginia corporation, governs Belle Heights. The Board of Directors of the Association approved the vacation of the Subject Right of Way by written consent, a copy of which is attached hereto as Exhibit B."

- The HOA Board is developer controlled, according to the office of the Ombudsman, the only named board member is one Russel Harper Jr who is not a homeowner.
- The Transitional Board composed of myself and another member (who do not have board control) are strongly opposed to this proposal.
- It was stated in the planning meeting that this was sent out of formality for permission of abutting landowner during declarant control but the letter was sent two months after the final property in the neighborhood sold. The neighborhood was set to transition in October 2023 but the Declarant walked out of the transition meeting and refused to transition the neighborhood (it was later established that they did not have quorum).
- The HOA does not own abutting property, all properties were sold at the time
  of the letter. There is a line in the DPW section of ORD 2023-340 that states a
  set of terms as
  - "The applicant(s)/owner(s)/successor(s) shall be responsible for obtaining the written consent of all abutting landowners to the closing and other property owners within the block affected by the closing." As the HOA does not own abutting properties, these terms were NOT met, as an abutting property owner I urge city council to discuss why these terms were not met with DPW.
- Property owners within a block (including myself) have not been asked for written consent nor did all property owners receive notification of the change.

Moving to the issue as to why this proposal is not supported by my family as owners in proximity to the closure. My education is in Architecture and Design, I live in the City because I appreciate density and walkability among other things. While this proposal supports density of the parcel, it does so in a way that affects life safety.

• W 20th st. originally connected to Semmes before Manchester Town Center LLC

- closed/demolished it for construction of Belle Heights. It was communicated to all homeowners during purchase of the home that this would be a reestablished entrance once construction had completed.
- The proposed road to Cowardin funnels traffic straight to Sioux Falls Alley. As in the name, this is an Alley and therefore is much narrower (two cars cannot pass by each other traveling opposite ways) than a road and has no sidewalks or other way of pedestrian access. Being a homeowner on Sioux Falls involves walking in the alley to access the back of our house and the driveway. Funnelling traffic from the proposed road to an alleyway would prove dangerous for a narrow pass that is already used as a cut through.
- The majority of traffic both from our neighborhood in addition to future development will require access to Semmes either through personal vehicle or public transit. The road to Cowardin puts drivers moving southbound on a road notorious for speeding in which drivers would have to make a tricky u-turn. Most current residents are either going into the city, north of the city, or east and west of the city. All of these options require utilizing Semmes to go either northbound or east/west. The proposed road does not serve the same traffic design intent as the current street at 20th st.
- Additionally, if there is only one access to Semmes, this will lead to the future development utilizing Belle Heights as a cut through to access 21st and Semmes ave. intersection. Belle Heights is a vibrant neighborhood that sees pedestrian as well as bike traffic throughout every day, this would prove detrimental to the walkability/safety of the neighborhood.
- Lastly, access on Cowardin as a more narrow road slows emergency personnel in their access of Belle Heights as well as the surrounding parcels. The fire station is located on Semmes, maintaining two entrances on Semmes allows for more open access in case of emergency.

In the planning meeting, it was discussed that DPW issued Certificate of Occupancy (CO) for the neighborhood given the two access points despite the access points not being the ones reflected on ORD 2019-013. Perry street is still a vague and gray area as far as access goes as it is a CSX easement. I am unsure as to why DPW would have issued COs for something that is not wholly a city owned street when ORD 2019-013 always reflected the improvement of 20th street for reconnection of the grid. A scenario was brought up in the planning meeting that a bad accident at 21st street could potentially cripple the neighborhood's access to Semmes completely as we've seen an uptick of accidents since the construction of Belle Heights. I woke up to a loud crash Wednesday morning as just that scenario played out, a severe accident at 21st street involving 3 vehicles and a large work truck/trailer combo (picture attached) closed Semmes eastbound and completely blocked 21st street forcing all neighbors to make the dangerous move across three lanes of cowardin to pull a U-turn. The intersection was closed completely for over an hour with cars having to back all the way out of 21st street, even after Semmes was reopened, the totaled cars were moved into the neighborhood entrance rendering half of 21st street unusable and unsafe hours after the incident.

It was stated by the planning commission that DPW could work out these issues as they arise but my question is, why is a reactive decision being made rather than a proactive one based on solid principles of urban planning in alignment with the Richmond City Master Plan? There are two petitions in both the Springhill and Belle Heights neighborhood that reflect a consensus from people already living through the struggles of the location that ORD 2023-340 would be detrimental to the area. I fear for my safety as well as my loved ones if Sioux Falls,

an alley, becomes a major vein of traffic moving cars from the apartment complex to a backed up 21st street. It is not an acceptable form of planning to utilize a residential alley unable to fit two widths of cars as a major artery connecting a multifamily project to the interstate/downtown infrastructure. I urge you all to come to the neighborhood and see the current conditions before voting on a piece of legislation that cannot be undone. We do not have to continue the cycle of reactionary planning in the southside, it is a desirable place for developers, projects in nearby areas like the Costar expansion and the outdoor music venue prove this. Making a decision that affects the life safety of Richmond City residents purely for the sale of a property will have lasting impacts on the success of the area and stands to set a dangerous precedent.

I would love to see this parcel developed into something that as a gateway site to the southside, reflects what a vibrant and unique city Richmond is. I support urban density and projects to improve the southside while maintaining pedestrian/bike safety. Unfortunately, the proposal does not meet this criteria and would pose a significant life safety risk for my family, neighbors of Belle Heights, as well as members of a future development on that parcel.

Dear City Council Member,

I am writing in opposition of the ordinance 2023-340 which will be heading for a vote at City Council in the coming days.

The ordinance vacates the public right of way and proposes the permanent closure of W20th St between Sioux Falls Aly (Belle Heights Neighborhood) and Semmes Ave.

The developer argues that this allows higher density construction.

If approved, the ordinance will create a new development along Semmes Ave without direct access to this artery. Instead the traffic will use the Belle Heights Neighborhood streets and access to major roads.

During the planning commission meeting, tax revenue, housing crisis and having the lot vacant for too long were mentioned as reasons to pass.

It became clear to everyone that DPW approved the traffic situation without any recent traffic study.

The very next day, a scenario I had asked the commission members to imagine actually happened: An accident blocking the Belle Heights only access to Semmes Ave in the direction most traveled and that the majority of the 220+ Belle Heights residents, and additionally the same amount of residents from the new development having to exit southbound on Cowarding Ave and making U-turns over 3 lanes.

Both Masterplan and Ord 2019-013 suggest a reconnection of the existing grid. I would like to ask City Council Members to visit the location prior to a vote. I am happy to meet.

I am certain that you will agree with me in that

- higher density can be achieved with other means than this irreversible closure
- a few additional units will neither solve the housing crisis, nor break the city's bank.
- keeping the street open and public ROW will reduce or avoid unsafe traffic conditions
- the Richmond 300 Masterplan and ORD 2019-013 got it right.

The developer had declared that his client would walk away if the decision was not made immediately. The decision was postponed by 4 weeks. At this week's meeting, we heard a similar statement, i.e. the client had not walked away. The proposal and arguments are full of similar misleading statements.

The developer has not demonstrated experience with residential projects and I would ask City Council to look for a solution that involves a company which can deliver a development which

- Delivers on the Richmond 300 masterplan
- Creates the housing units we need
- And does not increase traffic woes and risks citizens' safety

We can do better as a city.

I am preparing a traffic survey among Belle Heights residents in support of above statements and will make the data available at the City Council meeting

I hope this message finds you well, and congratulations on the new addition to your family.

I am writing to you as a concerned resident of Belle Heights, regarding the proposed ordinance to close the unimproved portion W 20th Street (ORD. 2023-340). This proposal has raised serious concerns in the community around safety and traffic flow. I am also personally extremely concerned about the effects on pedestrian safety at the intersection of W 21st St. and Semmes Ave.

As I am sure you are already aware, the existing conditions at W 21st St. and Semmes Ave. are already perilous for pedestrians. Despite being the connection for our neighborhood to the James River Park System, the Springhill Community, and the north side of the city in general, the intersection lacks any safety measures at all. This has led to numerous near-misses, I myself have come within inches of being hit by a car while crossing Semmes Ave with my dog. The closure of W 20th St and subsequent development would route a substantially increased volume of vehicular traffic to this intersection. Implementing a street closure, without addressing these pre-existing safety concerns, will not only exacerbate the current situation but also put pedestrians at an even greater risk.

Additionally, the Developer behind the ordinance has proposed adding a right hand turn lane to W 21st St as way to lessen traffic impacts of this change. However, a turn lane will here make the intersection even more dangerous for pedestrians by widening this intersection and adding an additional vehicle movement where drivers will make right make right hand turns at higher speeds. A turn lane will also lengthen the crossing distance for pedestrians crossing W 21st St. Pedestrian traffic is likely to increase at this intersection with the addition of the proposed new apartment homes and the construction of the Commonwealth Catholic Charities development across the street.

At the planning commission meeting on January 2nd, the feedback from the community regarding this change was unanimously negative. The residents here are united in their concern – a unified voice that deserves to be heard and acted upon. The community here knows, from everyday experience, that this change will have negative impacts for the area, especially with regards to safety.

Given these considerations, and in alignment with our city's commitment to Vision Zero, I urge you to reject the proposed street closure and continue to push for safety changes to Semmes Ave and particularly the intersection with W 21st. St.

I am writing as a civic leader in the Springhill Neighborhood. At your January 8, 2024 Council meeting you will begin the review process of proposed ORD 2023-340 - which was recommended for approval by the Planning Commission at their January 2, 2024 meeting. The Springhill Neighborhood asks that you oppose ORD 2023-340 which otherwise would allow the property developer to vacate their original plan to re-establish a specified portion of W 20th St., including the portion demolished when clearing site.

To find out what the people living in neighboring Springhill thought about the proposed ordinance, I personally knocked on every door in Springhill. *Everyone that answered* the door opposed the elimination of W 20th St. and signed the attached petition. Further, they shared concerns about the new developments' current impacts. The attached petition was presented to the Planning Commission earlier this week.

The original plans for developing Belle Heights include completion of W 20th St. The street was also included in materials presented to purchasers of the new Belle Heights townhomes. That portion of the street grid is vital to traffic flow in and out of the Belle Heights neighborhood, *even before* approximately 240 new apartments are built along the 2000 and 1900 blocks of Semmes Ave (south side) plus twenty *senior* apartments on the 1900 block (north side) of Semmes Ave which have already been approved and are underway. Completion of the street grid helps the interconnectedness of neighborhoods and helps vehicles and pedestrians move freely.

The original SUP for the redevelopment of the former tobacco warehouse property on the south side of Semmes Ave did not include the property that used to be a trailer park. It did not include all of the Semmes Ave parcels between W 20th St and Cowardin. These contiguous properties along Semmes Ave are all now a part of Harper developments. As such, the cumulative effect on the neighborhoods is not being well thought out nor planned appropriately with the residents' best interests in mind. We have already lost safe pedestrian and vehicle passage. We need W 20th St. completed to mitigate some of the congestion and speed consequences today, as well as after the build-out of the new residences is completed.

Please support better planning for our neighborhoods by opposing ORD 2023-340.


