1. THE CITY OF RICHMOND HEREBY ORDAINS:
2.           § 1. That Section 10-1 of the Code of the City of
3. Richmond, 1985, be amended and reordained as follows:
4.           Sec. 10-1. List of registered voters.
5.           (a) Manner of obtaining[;-fee]. [~~The general~~
6. ~~registrar is authorized to furnish to any person a true copy~~
7. ~~of the entire list of the names of all persons admitted to~~
8. ~~registration as a prerequisite to vote in elections held in~~
9. ~~the city required to be prepared and posted by section-~~
10. ~~24.1-56 of the Code of Virginia, or a specific (for example,~~
11. ~~a precinct) portion of the list of names of persons admitted~~
12. ~~to registration as a prerequisite to vote in elections held~~
13. ~~in the city. -- Any person who desires a copy of such list or~~
14. ~~specific portion of such list shall apply to the general-~~
15. ~~registrar therefor in writing and the copy of the list~~
16. ~~or portion of such list shall be furnished as soon as~~

1. ~~practicable after receipt of the application therefor upon~~  
2. ~~the payment into the city treasury of such fee as shall be~~  
3. ~~ascertained and fixed by the city manager in accordance with~~  
4. ~~the provisions of section 12-263.]~~ Lists of registered  
5. voters shall be obtained from the central registration  
6. roster of voters established and maintained by the state  
7. board of elections in the office of the secretary of the  
8. state board of elections as authorized in subsections (8)  
9. and (10) of section 24.1-23 of the Code of Virginia.

10. (b) Copy in registrar's office; availability for  
11. public inspection. The general registrar shall keep at  
12. least one copy of the list required by sections 24.1-49 and  
13. 24.1-56 of the Code of Virginia in his office, and such copy  
14. shall be available for public inspection at all times during  
15. the hours the office is open to the public.

16. (c) Reproduction and sale. It shall be unlawful for  
17. any person to reproduce any copy of such list or any part  
18. thereof and sell or offer such reproduction for sale.

19. (d) Removal from place of posting. It shall be  
20. unlawful for any person, except a person duly authorized so  
21. to do, to remove any copy of such list or any part thereof  
22. from any place where a copy thereof is posted in the city as  
23. required by section 24.1-49 of the Code of Virginia.

24. § 2. This ordinance shall be in force and effect upon  
25. adoption.
