#### Ordinances & Resolutions for Consideration

##### 1. Ordinance No. 2023-195

Patron: Mayor Stoney

##### Key Points

- To authorize the Chief Administrative Officer, for and on behalf of the City of Richmond, to execute a My Life Coach Academy Grant Contract between the City of Richmond and Rings vs. Rent Scholarship Foundation for the purpose of funding the implementation of a summer youth leadership development program for Martin Luther King, Jr. Middle School (MLK) students.
  - This is a partnership agreement with RPS to engage 6<sup>th</sup> and 7<sup>th</sup> graders at MLK.
  - MLCA engages students identified due to behavioral and/or attendance challenges in activities that build protective factors against youth violence and increase school engagement.
  - The program will engage 10 students in a six-week summer camp program (Mon- Thursday) in summer 2023.
  - The program provides engagement strategies that foster self-care and a career-focused life-style for continuous life learning and success planning strategies for at-risk youth. MLCA aligns its activities with school-wide initiatives and partners closely with the school principal to establish and track goals, which have been focused on student attendance and behavior.

  - o This is the approval of the plan of services of the Department of Justice Services of the City for Richmond as the City's local plan for the development, implementation and operation of the City's community-based system pursuant to the VJCCA.
  - o The City of Richmond receives \$374,683 from the Virginia Department of Juvenile Justice Services effective July 1, 2023.
