

A motion was made by Commissioner Easterling, seconded by Commissioner Danese to defer the application to allow the applicant to provide additional information to the Commission. Specifically, the Commission requested more information on the intent of the applicant regarding the porch enclosure and its use. The Commission also requested a revised design of the conservatory enclosure that features a simplified window and base paneling design, and that

the location of any exterior HVAC equipment for the enclosures on visible elevations be submitted. Overall, the Commission found the design to be appropriate in terms of preserving historic materials but were hesitant, and mostly not in support of the enclosure of the side porch, given the visibility of the porch and its connection to the street, as well as the guidelines specific recommendation that porches on primary elevations should not be enclosed. There was concern that enclosing the porch could reduce the building's interaction with street, and installation of interior blinds would ruin the intent of the openness of the design; although the Commission acknowledged that if enclosed, their purview is limited to the exterior.

A motion was made by Commissioner Bootsma, seconded by Commissioner Hill, to approve this application for the reasons stated in the staff report provided the following conditions are met: Any historically original or significant features are retained and repaired where possible. Any salvaged material that are used be aligned with historically appropriate elements for the final building's design. Any remaining original historic features, particularly the engaged front porch column (right side), are prioritized for preservation or replaced in-kind if beyond repair. The front porch roofing should reflect flat lock or field formed standing seam design. On the façade, the second floor retains its historic design and fenestration pattern; any replacement door including, one with a half-light, be submitted for administrative approval; On the façade, any door that is to be removed on the ground-level should be replaced with a window and infill that fit

within the existing doors exact dimensions. Additionally, any door that is to be restored and retained shall be submitted to Staff for administrative review and approval. Applicant receives all necessary permitting approvals. Any evidence of lap siding is found beneath the asphalt shingles of the rear addition it should be preserved if possible or if deteriorated beyond repair may be replaced with a smooth, unbeaded composite siding. Final siding to be submitted to Staff for administrative approval. Existing chimney is referenced or retained on the exterior. Final fence design and material to Staff for administrative approval; and exterior trim pieces be installed on the rear and side elevations that demarcate the new second story addition from the original portion of the building, following the original roof line.

A motion was made by Commissioner Moore, seconded by Commissioner Rodriguez, to partially approve this application. Staff Recommends approval of: Replacement of front porch metal railing with sawn pickets; matching those seen in the 1950s photograph and at 402 & 404 West Clay Street. Any new rail on the east elevation's stoop be a simple design, such as Richmond Rail, or a design substantiated by historic documentation; final materials and design submitted for Administrative Approval. Installation of new turned posts that match those at 402-404 West Clay Street, or a simplified design matching the proportions/dimensions (turned to square portion ratio) of original posts. Final design submitted for Administrative Approval. If the existing cornice remains, it be retained/repared. If a new cornice is installed, it replicates the neighboring cornice or be a simplified design and aligned with 402 West Clay Street; final treatment/design submitted for Administrative Approval. Original dentil detailing be retained/repared. If new detailing is to be installed, it be based on historic documentation or be a simplified design that matches the proportions of the original, aligning with 402 West Clay Street. New porch roof material be flat lock metal, or a dark colored membrane submitted for Administrative Approval. Original doors, windows, frames, transoms, and decorative features be retained/repared. New rear widows be two-over-two with SDLs; the muntin's of which match the width of the existing as closely as possible. Painting of previously painted brick only using a color that is similar to the color of the original brick. New wooden fence be submitted for Administrative Approval. Repointing match original mortar joints in depth and profile. The painting of the rear stucco; color to be submitted for Administrative Approval; and the approval of using a red lime wash on unpainted masonry on the eastern side elevation only.

The Commission denied: The painting of all unpainted masonry. The selected replacement turned posts.
