Call to Order

Council President Michael Jones called the meeting to order at 6:01 p.m. and presided.

Invocation was offered by Reverend Benjamin Campbell of St. Paul's Episcopal Church, 815 E. Grace Street, Richmond, Virginia.

Members of Council and the audience recited the Pledge of Allegiance.

Chamber Emergency Evacuation Plan Announcement and Citizen Speaker Guidelines

Upon the President's request, Deputy City Clerk RJ Warren provided information on the appropriate manner in which the Council Chamber is to be evacuated in the event of an emergency along with citizen speaker guidelines.

Councilor Katherine Jordan arrived at 6:10 p.m. and was seated.

Councilor Stephanie Lynch, on behalf of City Council, honored and recognized Pastor Robert A. Winfree and the congregation of New Life Deliverance Tabernacle for the services performed on behalf the residents of the Belt Atlantic Apartment Complex, and for the church's ongoing work on behalf of city residents.

Citizen Comment

[CD.2023.001](#) January 9, 2023 Citizen Comment Period Speakers List

President Michael Jones discussed Council's standards of procedure related to the Citizen Comment Period and requested that members limit discussions with individuals that provide comments.

Daisy Weaver, Richmond Retirement System Board of Trustees Chair, Richmond Retired Employees President, addressed Council and informed Council that city retirees were interested in the possible changes to the city's retirement system. Ms. Weaver stated that it was important to give retirees enough time and adequate staff support to review potential changes prior to implementation.

John Marcus addressed Council and stated his concerns with the city charging local civic associations for the use of facilities at city-owned community centers. Mr. Marcus also stated his concerns with the city amending the rules for the use of short-term rentals in the city.

Brian Blevins, Carytown business owner, addressed Council and informed members that trash pickup and other beautification efforts in Carytown required additional funding from Council.

Bobby McIntosh addressed Council and informed members that he was a property manager in the city. Mr. McIntosh stated that property owners and management experienced much difficulty retaining renters and maintaining property maintenance due to the impact of the COVID-19 pandemic and the current economy.

Public Hearing

Tamara Barker spoke in opposition of ORD. 2022-365, and stated that the proposed emergency housing shelter at 2800 3rd Avenue lacked access to reliable public transit. Ms. Barker also stated her concerns that Fifth Street Baptist Church did not have the resources necessary to provide adequate care to individuals that would be housed at the emergency shelter.

Bryce Fiske spoke in opposition of ORD. 2022-365, and informed Council of his own experience with crime related to individuals that use temporary housing facilities. Mr. Fiske stated his concerns that the proposed emergency shelter would be available for use on a year-round basis, and not just inclement weather situations. Mr. Fiske also stated his concerns that the residents of the surrounding neighborhood did not have a civic association to represent concerns to the city.

David Breslin spoke in opposition of ORD. 2022-365, and informed Council that he lived across the street from Fifth Baptist Church. Mr. Breslin stated that he would be negatively impacted by the emergency shelter. Mr. Breslin also stated his concerns that Fifth Street Baptist Church did not have adequate staff support and was not prepared to provide the necessary services to individuals using the shelter.

Diann Fletcher spoke in opposition of ORD. 2022-365, and informed Council of her experiences working in a hotel that provided temporary emergency shelter to residents. Ms. Fletcher stated that she did not believe Fifth Street Baptist Church was prepared enough to protect individuals within the emergency shelter.

Anthony Ford spoke in support of ORD. 2022-365, and informed Council of his own experiences with homelessness. Mr. Ford stated that the church community helped save his life when he was homeless, and he requested that Council allow Fifth Street Baptist Church to proceed with the shelter.

Maggie Green-Wright spoke in support of ORD. 2022-367, and she stated her appreciation for the engagement of the project's development team.

Weldon Hill, Good Shepherd Baptist Church Member, spoke in support of ORD. 2022-325, and spoke to the impact of Dr. Paul Nichols on the city's youth and Dr. Nichols's professional achievements.

Paul Stuart Pleasants, Calvary Baptist Church Pastor, Good Sheppard Baptist Church Assistant Pastor, spoke in support of ORD. 2022-325, and stated that Dr. Paul Nichols had a significant impact on the city's youth through guidance and mentorship.

Carolyn Lewis Chambers, Good Sheppard Baptist Church Deacon, spoke in support of ORD. 2022-325, and informed Council that Dr. Paul Nichols provided her family much comfort and support when she was a child.

Milondra Coleman spoke in support of ORD. 2022-325, and informed Council of her positive experiences involving Dr. Paul Nichols when she was a childhood friend of his daughter.

Reverend Dr. Leo Whitaker, Baptist General Convention of Virginia Executive Minister, spoke in support of ORD. 2022-325, and stated that he was previously a theological student of Dr. Paul Nichols. Dr. Whitaker informed Council of notable ministers that received education from Dr. Nichols.

Brenda Dabney Nichols, wife of Dr. Paul Nichols, spoke in support of ORD. 2022-325, and stated her appreciation for the patrons of the proposed ordinance.

Craig Watson, Fifth Street Baptist Church Administrator, spoke in support of ORD. 2022-365, and stated that Fifth Street Baptist Church took care of and assisted him and his family when he was younger. Mr. Watson also stated that Fifth Street Baptist Church would be able to sufficiently provide services to individuals in need.

Councilor Ellen Robertson stated that the city was experiencing a severe housing crisis. Councilor Robertson also stated that Fifth Street Baptist Church was well known in the Highland Park Community for its ability to assist individuals in need. Councilor Robertson further stated that ORD. 2022-365 would provide a positive impact on individuals seeking shelter, and she requested that her colleagues support the proposed ordinance.

Councilor Stephanie Lynch noted her support for ORD. 2022-365, and she stated that the city would work to ensure that homeless services would be provided to individuals seeking assistance at Fifth Street Baptist Church and other emergency housing locations.

Councilor Katherine Jordan stated her appreciation for individuals that provided comment in support of ORD. 2022-325, and she requested to be added as a co-patron of the proposed ordinance.

Councilors Andreas Addison, Ellen Robertson, Stephanie Lynch, Reva Trammell, and Vice President Kristen Nye requested to be added as co-patrons of ORD. 2022-325.

Councilor Cynthia Newbille stated her appreciation for individuals that spoke in support of ORD. 2022-325. Councilor Newbille also stated that it was an honor to patron the proposed ordinance.

Councilor Stephanie Lynch left the meeting at 7:17 p.m.

President Michael Jones stated that Dr. Paul Nichols had a positive impact on all preachers that attended Virginia Union University. President Jones also stated that he believed that Fifth Street Baptist Church would be sufficiently staffed to address homelessness issues and provide required services.
