Mr. Jay Brown, Director of Budget and Strategic Planning, provided staff's presentation.

Mr. Murthy asked related to the actual need for paving in the City, what is the percentage?

Mr. Brown stated I believe the need is over \$100M.

Mr. Thompson asked is this the Transportation Bill that we have been reading about.

Mr. Steidel stated there are two transportation bills, one the Governor has put through the General Assembly statewide for the Virginia Department of Transportation costs and there is a specific bill for the Virginia Transportation Authority.

Mr. Hepp-Buchannan asked, \$1.9M in sidewalk projects, how does that compare to what was spent last year.

Mr. Brown stated \$1.2 we have appropriated in the current year budget for sidewalks.

Ms. Reid asked when is the last time the City can actually say all of their roads were in the condition of fair and above.

Mr. Steidel stated I don't know if we could ever say that. To get them all to fair is a good accomplishment. At the end of that time, that investment would be a maintenance cost.

Ms. Reid asked, in regard to the investment that we are putting in City Hall Security, was there a security plan that was done that spoke to the need of City Hall Security.

Mr. Steidel stated we have a security plan for Courthouses and City Hall. It is a comprehensive plan meant to address everything that we understand is best practice for a municipal government facility that has public access. We are beginning that process with this budget to be able to start that plan.

Mr. Poole stated it is very difficult for the Planning Commission to ask intelligent questions about your plan without having it before us. I would ask that you consider in the future allowing us to have that prior to the presentation.

Mr. Steidel stated we have changed the way we do things, so right now the project managers are working on FY22, it would be great if we could come as a team to tell you what is going on with the FY22 so you have been discussing now what you will see next year.

Ms. Reid stated one of the reasons why we do the five year and the reason why Budget provided the information as early as last night, one of our methodologies in doing the five year and even looking 20 years out is not to do a lot of changes to the plan years so that you can make long term decisions.
