#### **Public Art Commission**

Ordinance No. 2024-212, adopted September 23, 2024, officially established the Public Art Commission, and describes the form and function of the commission in City Code. The commission shall be composed of nine members as follows:

- (1) The Mayor shall appoint one member and the Council shall appoint eight members.
- (2) Every member who is not also a member of the Council shall (i) be a resident of or have their place of work in the city of Richmond, (ii) hold no office of profit under the city government, and (iii) have considerable knowledge of and experience in the visual or performing arts.
- (3) Of the Council's eight appointees, at least four shall be arts professionals, one and only one shall be a member of either the Urban Design Committee or the City Planning Commission, and one and only one shall be a member of the Council.

# CITY OF RICHMOND PUBLIC ART COMMISSION

February 13, 2025

To whom it may concern,

The new membership for the City of Richmond's Public Art Commission (PAC) represents an exciting opportunity. The Public Art Commission, which advises the City Planning Commission (CPC) on matters involving public art, plays an important role in supporting the arts in Richmond. As a City Commission, it is imperative that the PAC reflect this City in the inclusivity and diversity of its membership. This next iteration of the PAC is an opportunity to ensure that a variety of voices and backgrounds tied to the arts make up this new group of Commission members.

The recommendations below have been selected not only for what they can bring to the PAC, but for how they can help move public art forward into a new chapter that aligns with the Mayor's Arts & Culture priorities. These include increasing access to arts experiences, improving the Arts District, and expanding the capabilities of the City's art program.

In addition to the requirement stipulated in Ordinance 2024-212 that four of the members be arts professionals, the membership needs of the PAC include individuals with the following types of knowledge or experience: communications, development, planning, community engagement, placemaking, public art projects, visual arts, performing arts, murals, festivals, architecture, local art organizations, non-profits, grants, and general arts administration/management experience.

These areas of expertise connect to the daily operations and goals of the PAC and its overarching mission to increase the availability, accessibility, and quality of public art throughout the City. The new members will support the evolution of the PAC as it pursues initiatives related to the Arts District (including a storefront art program), murals, art festivals, grant opportunities, and more. As such, membership distribution is less about district representation and more about areas of knowledge that will best serve the art program.

In addition to the arts professionals requirement, Ordinance 2024-212 requires that of the nine members, one individual must be a member of the Urban Design Committee (UDC) or CPC, one must be a Councilmember, and one shall be appointed by the Mayor. Due to the large number of applicants and the specific needs of the PAC, the review process was highly competitive. The experience and expertise of each applicant were considered in relation to the PAC's mission and goals, including the Mayor's Arts and Culture priorities; as were the need for diversity and inclusion. Much care and consideration have been given to the eight recommendations below.

**Taron Sparks (a.k.a. Silly Genius):** A prolific street artist with murals throughout the City, he is a vocal arts advocate and community organizer who established All City Art Club, a collaborative arts project focused on the improvement of the community through street art. This arts professional has extensive experience with multiple areas that would support the City's Public Art program, including murals, festivals, local art organizations, non-profits, grants, and more.

**Brian Barr:** A VCUarts professor, this artist and arts professional worked with public and private partners to activate vacant downtown Detroit storefronts with art. He also coordinated an art program for City offices and secured a grant for downtown community events in Detroit. He has relevant experience with grants, development, placemaking, festivals, and more.

**Holly Gordon:** Currently the Senior Community Engagement Manager at PlanRVA, this arts professional has worked with local artists, including muralists, on a variety of different public art projects and festivals over the past two decades. She has a wide array of experience with communications, community engagement, non-profits, local art organizations, performing arts, and more.

**Elizabeth Dolan Wright:** This philanthropist and arts professional is committed to bringing more public art to Richmond, having established the Common Wealth Public Art Fund in 2023 to support the creation of art installations while partnering with artists, donors, non-profits, and local government. She has extensive experience with development, non-profits, and arts management and is actively engaged with a variety of local art organizations as a board member.

**Ricky Parker:** This entrepreneur has 20+ years of marketing and communications experience in the creative arts industry. Involved with the performing as well as visual arts, he established the Hip Hop Studies Program at Virginia Union University and coordinated the Black is Beautiful billboards project in 2020. He has been involved with a number of organizations as a board member and creative director, with experience in communications, public art projects, and community engagement.

**Andrea Almond:** The most recent Vice Chair of the PAC, this architect with 3North has 25+ years of experience working on public and private projects that involve public art. A former UDC member, she has a long history of working with local government and understands the unique challenges and opportunities presented by incorporating public art into architecture as well as the landscape. As a former PAC and UDC member, her institutional knowledge is significant. Her background includes planning, placemaking, architecture, and public art projects.

**Jessie Gemmer:** A current UDC member and VCUarts professor, this architect designs public spaces and is involved with the Storefront for Community Design as well as various architectural committees. Her relevant experience includes architecture, placemaking, planning, and current UDC membership.

**Nicole Jones:** Councilmember for the 9<sup>th</sup> District and Deputy Director of ART 180, she is a dedicated, passionate champion of the arts. She understands the importance of the arts and this Commission and has extensive experience with community engagement, non-profits, local art organizations, and more.

I am confident that the individuals listed above have the capacity and know-how to help advance public art initiatives and programs heretofore unseen in Richmond. A diverse group of arts professionals, their backgrounds reflect a wide array of knowledge and deep commitment to the arts which will go a long way in supporting public art in Richmond as well as ensuring a PAC that is closely connected to the local community and capable of advancing the Mayor's Arts and Culture priorities.

While the ordinance states that appointments shall occur in June with terms beginning July 1<sup>st</sup>, the City Attorney's Office has advised that in the meantime, interim appointments may be made to avoid continued disruption to PAC activities. It should be noted that members must be prepared to attend PAC meetings in-person due to strict limitations on virtual attendance.


