Call to Order

Council President Kristen Nye called the meeting to order at 6:07 p.m. and presided.

Chamber Security and Spanish Interpretation Announcement

Michael Winborne, City Hall Security Manager, announced security policies and expected conduct for members of the public present in the Council Chamber.

City Clerk Candice Reid stated that Spanish interpretation service was available in the Council Chamber and that attendees should speak with a representative to receive the appropriate equipment. Rabbi Adam Winston addressed Council and stated that Council does not have the authority to address international issues or affairs, specifically regarding the conflict in Gaza.

Dionne DiBlasio-Lenassi addressed Council and requested that members adopt a proposed ceasefire resolution related to the conflict in Gaza.

Drew Alexander addressed Council and provided statistics related to prior wars and conflicts involving the United States of America. Mr. Alexander stated the conflict in Gaza should be categorized as a war, and he noted that he believed civilian casualties could not be avoided in such war.

Chief Administrative Officer (CAO) Lincoln Saunders addressed Council and acknowledged Council and city staff that collaborated to draft the city's proposed budget for Fiscal Year 2024-2025.

Public Hearing

Sharon Gilbert, Richmond Public Schools (RPS) Administrative Office Associate, Richmond Education Association (REA) member, requested that Council amend the budget to provide needed funding for capital improvements for school facilities.

Charles Willis, United Communities Against Crime Executive Director, spoke in support of the amended budget and stated that the budget would benefit the city.

Inga Carr Bell spoke in support of school funding, and she stated that RPS facilities greatly needed the funding for maintenance improvements.

Ann Forrester, RPS Teacher, REA Vice President, requested that Council fully fund RPS. Ms. Forrester stated her appreciation for the amended capital improvement project budget related to RPS facilities, and she noted that continued investment in facilities will be necessary in the future.

A copy of the material provided has been filed.

Jasmine Cuellar requested that Council provide the requested funding for RPS.

Fern Diaz-Castros spoke in support of the capital improvement project (CIP) amendment related to RPS facilities.

Cole Oberman, RPS Teacher, REA member, requested that the city fully fund RPS, and he addressed the quality of RPS facilities. Mr. Oberman stated that RPS operations should also be fully funded, and not just the CIP budget requests.

Lisa Delao, RPS Teacher, REA board member, stated her appreciation for the amended CIP budget related to RPS facility investments, but requested that RPS fund even more investments such as supplies and healthy food.

Hannah Clayman, RPS Exceptional Education Teacher, REA member, requested that the city show investment in the city's youth by fully funding RPS.

Jacob Neal-Helt, RPS Teacher, REA member, requested that Council adopt the proposed amended budget related to RPS CIP funding.

Lynne Fetter stated it was important that the city fully fund RPS, and she noted her concerns about the debate related to funding schools.

Taylor Dayton stated she was a former RPS teacher, and she requested that the city fully fund RPS. Ms. Dayton also stated that if Council wanted young families to remain in the city, then more investments were necessary for RPS operations and RPS facilities.

Mac Atkins stated that the city should reallocate funding in the budget to fully fund RPS.

Mark Wood, Virginia Commonwealth University (VCU) Professor, stated his support for RPS teachers, and he requested that the city fully fund RPS.

Councilor Nicole Jones stated her appreciation for individuals that spoke in support of RPS funding. Councilor Jones also stated that the city needed to invest not only in RPS, but other aspects of the city's youth outside of schools.

Councilor Katherine Jordan stated that the city has increased RPS funding by \$88,000,000 over the past eight years. Councilor Jordan also stated that the city could save money by addressing RPS facilities maintenance now. Councilor Jordan further stated her support for collective bargaining being addressed in the city budget.

Councilor Stephanie Lynch stated that the city had proactively increased funding for RPS, and she noted her concerns that Council does not have any involvement with how RPS spends its funding once it is allocated.

Councilor Reva Trammell stated her concerns that Council does not have any involvement with how RPS spends funding once allocated.

Councilor Ellen Robertson stated her appreciation for individuals that provided comments related to the budget. Councilor Robertson also stated her concern about RPS facilities, and she noted her support for the amended budget that would provide additional CIP RPS funding.

Councilor Cynthia Newbille stated her appreciation for RPS teachers, and she noted her support for the increased RPS CIP funding.

Vice President Ann-Frances Lambert stated her support for RPS teachers, and she requested that the city increase its lobbying efforts regarding school funding requests from the General Assembly of Virginia.

President Kristen Nye stated that Council does not have any control of how RPS spends funding once it is allocated, and she recommended that RPS advocates connect with the Richmond School Board to review how the received funds are spent. President Nye also stated the city could save money by consolidating schools. President Nye further stated her appreciation for city administration and Council staff regarding Council's budget review process.

There were no further comments or discussions ORD. 2024-099, ORD. 2024-100, ORD. 2024-128, ORD. 2024-101, ORD. 2024-102, ORD. 2024-103, and ORD. 2024-104 were unanimously adopted.
