§ 1. That section 3 of Article III of Ordinance No. 93-117-159, adopted May 24, 1993,be and is hereby amended and reordained as follows:

Section 3. (Police and Fire Career Development)

For personnel assigned to the positions in the FP pay ranges, advancement shall be in accordance with the provisions of a "Career Development Plan" recommended by the Departments and approved by Human Resources and the Chief Administrative Officer. A copy of the approved plans and all amendments thereafter shall be the official plans and shall be filed with the Director of Human Resources.

[Advancement between classifications in accordance with Career Development Plans implemented pursuant to this section, except from Police Recruit to Police Officer I and from Fire Recruit to Fire Fighter I, shall be suspended for the period commencing July 3, 2010, and ending July 1, 2016.

Each employee who would be eligible for advancement on July 1, 2015, if the terms of this section were not suspended pursuant to the preceding paragraph of this section shall receive a one time adjustment in pay based on advancement from one classification to a higher classification in accordance with a Career Development Plan implemented pursuant to this section, effective beginning with the pay period beginning on July 11, 2015.]

§ 2. This ordinance shall be in force and effect on July 11, 2015.

ORDINANCE/RESOLUTION SUMMARY

An ordinance is requested to amend section 3 of Article III of the City's pay plan adopted by Ordinance No. 93-117-159 in order to reinstate the Career Development Program for sworn Police and Fire officers. Adjustment in pay based on advancement from one classification to a higher classification in accordance with a Career Development Plan implemented pursuant to this section, shall be effective beginning with the pay period beginning on July 11, 2015.

BACKGROUND

On May 27, 2014, Ordinance No. 2014-56-109 was adopted to extend the suspension of the Career Development Program and the Educational Incentive Program for certain Police and Fire Officers through fiscal year 2015. This legislation affected all sworn police and fire classifications except for Police Recruit, Police Office I, Firefighter Recruit and Firefighter I.

The suspension began July 3, 2010 and the legislation adopted May 27, 2014 extended the suspension for an additional year through July 1, 2015.
