Dr. John P. Lindstrom, Chief Executive Officer (CEO) of Richmond Behavioral Health Authority (RBHA) spoke in reference to meeting applicants that have a genuine interest in RBHA. Dr. Lindstrom stated that RBHA staff offers an informal "meet and greet" for applicants; however, staff does not make recommendations for applicants to sit on RBHA Board. Dr. Lindstrom also stated that four positions will be vacant as of July 1, 2022 and provided a brief review of reasons that members will be leaving RBHA.

*Chair Stephanie Lynch acknowledged Dr. Shonda Harris-Muhammed, the new Richmond School Board (RSB) chair, will periodically be joining the committee meetings to offer updates of the RSB.*

## **Presentation(s)**

### **Richmond Redevelopment and Housing Authority (RRHA) Update on Evictions**

Interim Chief Executive Officer of Richmond Redevelopment and Housing Authority (RRHA) Stacey Daniels-Fayson informed the committee that lease enforcement activities have resumed through RRHA. Ms. Daniels-Fayson stated that RRHA has been in an eviction moratorium for over two years with a self-imposed moratorium from November 2019 to February 2020, and a federally mandated moratorium from March 2020 to October 2021. Ms. Daniels-Fayson also stated that RRHA has had several media campaigns to reach out to residents to ensure residents can become current on their rent. She noted that information has been provided to Council members regarding previous efforts of RRHA.

Ms. Daniels-Fayson informed the committee that approximately 1,700 families are behind with rent as of February 9, 2022. Ms. Daniels-Fayson also stated that the majority of families owe greater than \$51.00 but less than \$500.00; however, 96 families have balances that are greater than \$1000.00 but less than \$5000.00. She further stated that as of February 10, 2022, 549 applications have been submitted through the Gov2Go application process which is administered by the Virginia Department of Housing and Community Development. Ms. Daniels-Fayson stated that if rental assistance is not available, RRHA will work with families to enter into a repayment agreement. Ms. Daniels-Fayson's stated that the goal is to have no evictions.

Ms. Daniels-Fayson responded to committee questions and thanked the committee for allowing the brief update on evictions.

Richmond School Board Chair Dr. Shonda Harris-Muhammed requested the number of RPS students that will be impacted by lease enforcement.

*Chair Lynch stated that staff would follow-up with Ms. Daniels-Fayson regarding Dr. Harris-Muhammed's request.*

### **Richmond Public Schools (RPS) Budget Update**

Superintendent of Richmond Public Schools (RPS) Jason Kamras provided an update regarding RPS's budget. Mr. Kamras stated that the \$98,000,000 balance of federal funds needs to be spent by the end of the 2023-2024 school year. Superintendent Kamras also reviewed the costs of seven goals showing needs of maintenance, staffing, and care for the mental health of staff and students. Mr. Kamras further stated that the costs will include expanded learning time, technology and other academic support such as additional teachers and support for students with special needs.
