PURPOSE: To provide a supporting resolution for the County of Henrico's amendment of its portion of the Joint Enterprise Zone (consisting of the City of Richmond Zone 28A and the Henrico County Enterprise Zone). The County would like to make deletions and additions to its zone boundary.

REASON: The Virginia Department of Housing and Community Development (DHCD) Enterprise Grant Program regulation requires that participating localities in Joint Enterprise Zones agree to any administrative actions requested of the agency by the neighboring jurisdiction. The agreement must come in the form of a signed Joint Application Agreement executed by the locality's chief administrator and the adoption of a resolution by the locality's governing body supporting such an agreement

RECOMMENDATION: Adoption of the resolution is recommended by the City Administration.

BACKGROUND: In April 2003, the City's North Enterprise Zone was redesignated by the Virginia Department of Housing and Community Development (DHCD) as a Joint Enterprise Zone with neighboring Henrico County. The County established a zone area (28B) contiguous to the City's Zone 28A. Both the County and the City can independently have 3,840 acres in their respective zone areas.

Acreage cannot be shared or exchanged between the two localities. The requested resolution supports the County in its request to DHCD to amend its portion of the zone. This action has no administrative or programmatic impact on the City's portion of the Joint Enterprise Zone.

The City is in the process of examining the boundaries of its Enterprise Zones and anticipates providing adjustment recommendations in FY 2025.

WHEREAS, the Virginia Enterprise Zone Grant Act authorizes the creation of enterprise zones in the Commonwealth of Virginia (the "Commonwealth") to stimulate economic development in designated geographical areas; and,

WHEREAS, Zone #28B, also known as the City of Richmond North/Henrico County Enterprise Zone (the "Zone"), is a joint enterprise zone of the County of Henrico (the "County") and the City of Richmond (the "City") that provides a combination of state and local incentives to promote economic development; and,

WHEREAS, the Zone was created on January 1, 1995, and the Commonwealth most recently renewed the Zone through December 31, 2027; and,

WHEREAS, the County desires to amend the Zone in the County to remove certain areas, incorporate additional areas, and modify the incentives, as summarized in Exhibit A to this resolution; and,

WHEREAS, the amendment will benefit economic and industrial expansion in the County to better meet the goals and objectives of the Virginia Enterprise Zone Grant Program; and,

WHEREAS, the County and the City must apply jointly for amendments to the Zone; and,

WHEREAS, County staff has notified all property owners potentially affected by the proposed boundary amendment and conducted a public information meeting on March 19, 2024, to discuss the proposed amendment.
