Vice President Ellen Robertson introduced ORD. 2022-054 stating that the proposed ordinance requests an additional at-large member be added to the membership of the Aging and Disabilities Advisory Board and an employee of the Office of the Deputy Chief Administrative Officer for Human Services. Ms. Robertson stated further that the information provided within the proposed ordinance has correct information regarding the employee member; however, the at-large member's information needs to be more descriptive. Vice President Robertson stated that an amendment is forthcoming and requested a 30-day continuance within committee.

Vice Chair Katherine Jordan left the meeting via Microsoft Teams at 2:14 p.m.

There were no further comments or discussions and Member Michael Jones moved to continue ORD. 2022-054 to the June 22, 2022, Governmental Operations Standing Committee meeting, which was seconded and approved: Ayes 2, Jones, Nye. Noes, None.

2. [ORD. 2022-091](#) To amend ch. 2, art. V of the City Code by adding therein a new div. 20 (§§ 2-1202.1-2-1202.5) for the purpose of establishing a Civilian Review Board.

Vice Chair Katherine Jordan and Alternate Member Ann-Frances Lambert arrived at 2:16 p.m. and were seated.

Mayor's Chief of Staff Maggie Anderson informed committee members that there had been previous discussion regarding ORD. 2022-091 and the Civilian Review Board, and should there be any questions or concerns she would respond.

Member Michael Jones stated that there had been communication with the Mayor's office regarding proposed ORD. 2022-091, and that a discussion with the mayor is forthcoming to discuss areas of concern. Mr. Jones also stated that based upon the outcome of the discussion, amendments to the proposed ordinance would be introduced or a replacement paper would be introduced. Mr. Jones also requested a 60-day continuation of ORD. 2022-091.

Alternate Member Ann-Frances Lambert requested to be involved in the amendment process.

Vice President Ellen Robertson exited the meeting at 2:18 p.m.

Chair Kristen Nye informed member Michael Jones that a discussion regarding the Civilian Review Board could be placed on the June agenda if additional information is learned prior to the July 27th committee meeting.

There were no further comments or discussions and Member Michael Jones moved to continue ORD. 2022-091 to the July 27, 2022, Governmental Operations Standing Committee meeting, which was seconded and unanimously approved.

3. [RES. 2022-R025](#) To express the City Council's support for highly prioritizing appropriations for the construction of combined sewer system plan projects by July 1, 2035, to improve water quality in the James River in a financially sustainable manner.

[Controlling Richmond's Combined Sewer Overflows Presentation](#)

Director of Public Utilities April Bingham introduced RES. 2022-R025 with a presentation that provided insight on the city's combined sewer system and combined sewer overflow. Director Bingham stated that the combined sewer overflow must be completed by July 1, 2035, as stated in Senate Bill 1064. Ms. Bingham provided a brief history on the water system and stated that on a rainy day, 40,000,000 gallons of sanitary sewage and over 100,000,000 gallons of municipal storm water is treated. Ms. Bingham also stated that the interim water treatment plan needs to be in place by July 1, 2027. Ms. Bingham stated further that communication with stakeholders is a priority and that two representatives from each district are participating in the development plan which is due in 2024. Director Bingham completed her presentation by stating that the city has a commitment to improve the combined sewer system, reduce the combined sewer overflow and improve water quality.

Vice Chair Katherine Jordan, Member Michael Jones and Chair Kristen Nye requested to be added as patrons.

There were no further comments or discussions and Vice Chair Katherine Jordan moved to forward RES. 2022-R025 to Council with the recommendation to approve, which was seconded and unanimously approved.
