

AN ORDINANCE NO. 86-112-137

ADOPTED MAY 28 1986

Adopting the Gas Utility Budget for the fiscal year commencing July 1, 1986, and ending June 30, 1987, and appropriating the estimated receipts of the Gas Utility for the said fiscal year and making an appropriation from the Gas Utility Renewal fund for renewing, rebuilding or extending the plant and distribution system of the gas utility.

1. THE CITY OF RICHMOND HEREBY ORDAINS:
2. § 1. That the budget designated the Gas Utility
3. Budget for the fiscal year commencing July 1, 1986, and
4. ending June 30, 1987, bound with the draft of the general
5. fund budget, a copy of which is attached to the draft of the
6. general fund budget ordinance, is hereby adopted and made a
7. part of this ordinance.
8. § 2. That the sum of \$76,224,300 be and is hereby
9. appropriated from the estimated receipts of the gas utility
10. for the fiscal year 1986-1987 for salaries, wages and other
11. expenses, including acquisition of equipment necessary for
12. Gas Production, Distribution, Supply and Marketing,
13. Customers' Accounting and Collecting and Administration of
14. the Gas Utility as set forth in the Gas Utility Budget.

1. § 3. That the sum of \$45,689 be and is hereby
2. appropriated from the gas utility renewal fund for renewing,
3. rebuilding and extending the utility as set forth in the
4. Utility Budget, the said appropriation having been
5. recommended by the Acting City Manager.

6. § 4. That the payment and settlement of claims of
7. any kind heretofore or hereafter asserted against the City
8. growing out of the operation of the gas utility and final
9. judgments heretofore or hereafter asserted against the City
10. on account thereof, together with all costs, interest, fees
11. for legal services and all other fees and expenses incident
12. thereto, and all fees, costs and other expenses incurred in
13. providing legal and other services authorized by Section
14. 2-37.10 of the Code of the City of Richmond, 1985, shall be
15. paid upon the approval and order of the City Attorney from
16. the funds herein appropriated for defraying the expense of
17. operating the gas utility; except that in the case of
18. judgments against the City, payment thereof shall be limited
19. to the extent of funds available in the appropriation for
20. the purpose.

21. § 5. This ordinance shall be in force and effect at
22. the first moment of the first day of July 1986, and shall
23. constitute the gas utility appropriation ordinance for the
24. fiscal year commencing on that date.
