As we begin to explore requirements for Community Benefits in development projects, we need to outline strategically the resources needed to support their success. To support "hire local" requirements we must have a robust and world-class workforce development operation for residents to gain the skills, experience, and licenses needed to compete in this work environment. Affordable Housing requirements need voucher based housing options as well as training for the transition from low-income neighborhoods to these new opportunities. In the FY2023 Budget, we need to outline funding to developing the strategies and resources needed to deliver in these priority areas.

#1: Gun Buyback Program

Funding Request: at least \$1million

Description: A gun buyback program would be part of a holistic approach to the gun violence epidemic. In Richmond last year there were over 90 homicides. Part of the problem is illegal weapons on the street as evidenced by the weapons that Operation Red Ball is recovering. These include assault weapons, rifles, and even grenade launchers.

A gun buyback program is supported by Chief Smith and could be a tool that will help keep these violent weapons out of the hands of our youth and violent criminals. The program would be run by RPD. Any efforts would be done in coordination with implementation of the recommendations from the gun violence prevention task force.

#2: City of Richmond on Wheels – Mobile Unit Social Services Pilot Program

Funding Request: at least \$1million

Description: This would be a mobile unit of service providers that would deliver social services such as mental health, dmv drivers licenses, corona virus testing; vaccination, etc. This would be a pilot program that would operate in the 3rd district and if it's successful, after 1 year, it could be expanded to other districts and/or citywide. The mobility of this unit improves access to these services for seniors, low income residents, and those without transportation.

Not only would service delivery be brought to the community, this mobile unit would operate during non-traditional hours. I.e. it would operate between the hours of 6pm – 2am so that working families could access these services. It will also operate during daytime hours.

Another objective of this program will be to encourage volunteer opportunities in the community. For example,

#3: Youth Jobs Program

Funding Request: At least \$1 million.

Description: This would be a pilot program that would take a certain number of youth from low income neighborhoods and provide job skill and on the job training that aligns with jobs that will be in the Richmond metro area over the next decade.

In addition to job training and skill development, youth would receive mentoring and life skills training as well. The formerly incarcerated would be hired as counselors who can teach young people not to go down the path they did when they were young. Therefore, this program would kill two birds with one stone because it would provide another vehicle for the formerly incarcerated to get gainful employment.

The program should align with the current workforce programs that Parks and rec and the OCWB administer. It should be run out of the Calhoun Center but can also be run out of the mobile unit as well.

Funding Request: \$100,000

Description: There is a dearth of parking along the Brookland Park Blvd. Corridor and North Ave. The current problems will only be exacerbated in the future. This budget allocation would be used to fund a study. The study's objective would be to investigate the possibilities with regards to utilizing existing city owned parcels

#5 - City Staff Salaries

Police and Fire:

Funding Request: TBD

Description: There needs to be a pot of money available in case there are delays in the Police study that the administration is executing. Given the attrition, low morale, within RPD, this would serve as a backup plan in case the timeline to increase police pay gets pushed back.

• Office of Aging and Disabilities:

Funding Request: \$75,000 (Human Services Analyst position Salary + Benefits)

Description: There is currently no staff member to deal with the disabled population in the office. In addition, no current staff speak Spanish, so both of these groups don't have the same level of services as the English speaking Senior Citizens. The request is for 1 bilingual staff member.

• Council Staff office's Request.

#1: Park Ranger Program

A Park Ranger Program would include PRCF staff trained and dedicated to provide enforcement, emergency and educational services to park users on-site. The park ranger program would lead to greater stewardship of park resources and a sense of security and welcome for all park users. Rangers would primarily patrol the city's largest and most populated parks but could be utilized throughout the park system to provide security and resources during events.

This request aligns with the goals of Richmond 300's Thriving Environment section and the Equitable Agenda's

#2: Soil and Water Conservation District

A Memorandum of Understanding with the Henricopolis Soil & Water Conservation District would allow the City to access existing natural resource management resources. A city-employed Soil and Water Conservation Coordinator would be required to manage Richmond residents' requests for services. This MOA and Coordinator position would allow residents to access valuable programs such as the Virginia Conservation Assistance Program (VCAP), an urban cost-share program that provides financial incentives and technical and educational assistance to property owners installing eligible Best Management Practices (BMPs).

#3: Right of Way Cleaning and Management

This additional funding would provide for a more robust street sweeping program, including more streets, bike lane and sidewalk cleaning, and greater frequency of cleanings. It would also cover increased maintenance of right of way trees and landscaping. Increasing these services would ensure that transportation infrastructure throughout the city is safe and inviting for all residents to use.

#4: Urban Forestry

An increased operating budget, including additional full time employees, would allow for the Urban Forestry Division to adequately care for city trees and provide resident education and services related to tree care. The division is not currently setup to carry out the Urban Forestry Commission's work and respond to constituent requests in a timely manner.

#5: Permitting and Plan Review

Permitting and Plan Review's backlog and understaffing continue to make it incredibly cumbersome for small and large development in the city. Increased funding would support the addition of FTE positions and improved systems for streamlining reviews. It could also cover a specific position for guiding small and minority businesses through the city's land development processes.

#6: Small Area Plan for Stony Point Fashion Mall

A Small Area Plan for Stony Point Fashion Mall would identify viable and desirable land uses for an area that was determined as a priority growth node in the Richmond 300 plan.

#7: Office of Aging and Persons of Disabilities

The Office of Aging and Persons of Disabilities is a critical resource to our growing elderly population and persons with disabilities across the city providing adaptive equipment, continued education, care coordination, and other services. A greater operating budget would allow the office to add needed staff and bolster its impactful programs.

Request #8: City Council Agency Budget Enhancements

City Council agencies require appropriations for all their request budget enhancements in order to provide the public efficient and exceptional service. This request is detailed in RES. 2021-R091.

All city agencies must be adequately supported and staffed in order for the city pursue Richmond 300 and

Request #9: Implementation of Police and Fire Pay Plan

This request (RES. 2021-R075) is the implementation any recommendations of the Department of Human Resources' pay plan study for compensation increases for sworn employees of both the Department of Police and the Department of Fire and Emergency Services. The city's public safety depends on our ability to retain our valuable police and fire employees.

#1: Portable Rental Subsidies

The waiting list for housing choice vouchers is in the thousands and our residents are bottle necked in a system that has no other alternatives for relieving the pressure valve. Local housing subsidies create a mechanism to give families and individuals the assistance they need to get into affordable housing, without having to rely on public or income-based housing complexes. With a local housing subsidy program, residents receive a cash subsidy, paid directly to a landlord to help them rent on the private market. The program wraps permanent supportive housing services around the recipients to ensure that they receive case management and other supports to keep them housed. Not only is this a way to alleviate the housing wait list, it is a way to deconcentrate poverty and allow for individuals to access the communities and social capital that they have been traditionally shut out from in concentrated public and income-based housing complexes.

#2: Public Safety – Gun Buy Back Program

Research states that gun buybacks can help if they are part of a broader effort to reduce gun violence. These buyback events can influence public's perception of how the city are handling gun violence and provide an opportunity to educate communities about gun violence reduction strategies.

Please remember that the full City Council adopted RES. 2021-R075. To request that the Mayor propose an annual budget for the Fiscal Year 2022-2023 that recommends an appropriation to implement any recommendations of the Department of Human Resources' pay plan study for compensation increases for sworn employees of both the Department of Police and the Department of Fire and Emergency Services required by Ord. No. 2021-040, adopted May 24, 2021, and to express the Council's intent that any one-time bonuses proposed by the Mayor to be funded, to the extent permitted by law, as premium pay from American Rescue Plan Act funds not replace or offset any compensation increases recommended for sworn employees of the Department of Police and the Department of Fire and Emergency Services in such study.

#3: Office of Planning and Development Review (PDR)

While we are excited about the appointment of Director Kevin Vonck and DCAO Sharon Ebert in the past few years, the department is still struggling to meet the expectations of the community. We continue to receive calls from residents and contractors stating they do not have the same wait times and communication delays with the surrounding localities. This department continues to have frozen or unfilled positions. If salary ranges are impacting the hiring process those need to be reviewed for our city to keep up with the growth we wish to support.

#4: Vision Zero – Office of Public Information & Engagement (PIE)

Speeding enforcement and other traffic are #1 concerns council offices are contacted about. We are very grateful to Captain Gleason and his efforts but recognize that his unit cannot cover the entire high injury network to the level the residents wish to see. We are excited to see the photo speed ticketing legislation before council later this month. Yet, disappointed we will not be able to get the general assembly to expand it to residential, business, park, and bridges due to not implementing what we already had authority to do. As DPW Traffic continues to review complaints from residents we recognize it often takes years to resolve a concern. (e.g. Speed tables that were approved three years ago are still not installed, Semmes Phase I & II has been a public conversation for 5+ years yet no ground has been broken, etc.) We have the ability to reduce speed in residential streets yet it comes with a \$2.5M+ price tag due to have to install signs since the city cannot set its own statue of speed on unmarked roads. We also recognize a large portion of all concerns involve the public not behaving in a certain manner (speeding, distracted driving, etc.). A social marketing campaign directed toward driving in the City of Richmond with the behavior change goal of slowing this city down would be ideal. While the Vision Zero

#5: Office of Aging and Persons with Disabilities

City Council offices heavily utilize the Office of Aging and Persons with Disabilities. Sadly, this office has been short a full time staff member during a pandemic. There has also been need for a full time staff member to solely assist with persons with disabilities. Currently, one person is doing this all. We are fairly confident that all council offices that send out mailers include this office's contact information on them. The office has stated they tell when something has been mailed out due to the spike in calls from seniors and persons with disabilities. If this office was to disappear or be folded into DSS we would lose a valuable support.
