### Call to Order

Council Vice President Ann-Frances Lambert called the meeting to order at 6:00 p.m. and presided.

### Chamber Security and Spanish Interpretation Announcements

Security policies and expected conduct for members of the public present in the Council Chamber were announced.

City Clerk Candice Reid stated that Spanish interpretation service was available in the Council Chamber and that attendees should speak with a representative to receive the appropriate equipment. City Clerk Reid also stated that Spanish interpretation service was available virtually through Microsoft Teams.

Roxana Talavera-Denson, Language Access Coordinator, Office of Immigrant and Refugee Engagement, then provided Spanish interpretation of previously provided announcements.

Apostle Leon Benjamin of New Life Harvest Church, 113 E. Belt Boulevard, Richmond, Virginia, provided the invocation.

Members of Council and the audience recited the Pledge of Allegiance.

## Chamber Emergency Evacuation Plan Announcement and Public Speaker Guidelines

Upon the Vice President's request, Assistant City Clerk Kimberly Morris provided information on the appropriate manner in which the Council Chamber is to be evacuated in the event of an emergency along with public speaker guidelines.

## Public Comment

Hannah Spector addressed Council and requested that members adopt a proposed ceasefire resolution related to the conflict in Gaza. Ms. Spector also stated her concerns regarding Council's response to the conflict.

Sherry Grinsteiner, Rabbi at Congregation Or Atid, addressed Council and stated her opinion about the conflict in Gaza. Rabbi Grinsteiner also stated her belief that Israel's action in Gaza was justified.

Christiane Riederer addressed Council about the conflict in Gaza and stated her concerns about the conflict's impact on children and noncombatants.

Sean Cassar, Democratic Socialists of America Richmond Chapter member, addressed Council and stated his concerns about affordable housing issues in the city. Mr. Cassar also stated his concerns about the city's funding priorities.

Miguel Diaz addressed Council and stated his concerns about the conditions of his newly constructed house and other recently constructed housing in the city. Mr. Diaz also stated that his home was subject to mold mitigation and that other recently built homes suffer from poor construction that impact the health of city residents. Mr. Diaz requested that the city fully staff the Department of Planning and Development Review inspection team and establish a rental inspection district.

Tyreka Singleton addressed Council and stated her concerns about issues related to her mother's death. Ms. Singleton also requested to be provided more information regarding the death of her mother.

Charles Pearce addressed Council and stated his concerns about his complaints not being addressed by the city. Mr. Pearce also addressed his concerns about burglary, drug trafficking, trash, safety, and loud music near his parents' house.

Kimberly Myris, New Virginia Majority member, addressed Council and stated her concerns about affordable housing in the city. Ms. Myris requested that Council and the city take action to help and provide services to residents experiencing housing instability.

### Public Hearing

Charles Skelly, President of the Richmond Building and Construction Trades Union Council and Business Manager of IBEW Local 666, spoke in support of ORD. 2024-186, and he stated that the trades union supported the proposed ordinance.

Malik Snipes, Laborers' International Union of North America (LiUNA!) member, spoke in support for ORD. 2024-186, and stated his desire to work a prevailing wage construction job in the city.

Laura McCann, Richmond for All Governing Board member, stated that Richmond for All was in support of ORD. 2024-186.

Jolinda Brown, LiUNA! member, spoke in support for ORD. 2024-186, and stated her concerns that a Diamond District contract labor agreement had yet to be established that includes prevailing wage jobs.

Montrell Gilmore, LiUNA! member, spoke in support for ORD. 2024-186, and stated his desire to obtain a prevailing wage job involved with the construction of the Diamond District.

Tyquan Jones, LiUNA! member, spoke in support for ORD. 2024-186, and stated his concerns about a project labor agreement related to the construction of the Diamond District, and he informed Council that he wanted to work in the city.



Kayon Davis, LiUNA! member, spoke in support for ORD. 2024-186, and he stated his desire to work a prevailing wage job related to the Diamond District construction project.

Chris Hollis, LiUNA! member, spoke in support for ORD. 2024-186, and he stated that laborers that live in the city want to work prevailing wage jobs on city construction sites.

Adrian Bryant, LiUNA! member, spoke in support for ORD. 2024-186, and he stated his desire to live and work a prevailing wage job in the city.

T. Preston Lloyd, Jr., Williams Mullen attorney, spoke in support of ORD. 2024-263, and he stated his appreciation for the work of city administration. Mr. Lloyd also stated the ordinance would help a proposed affordable housing development move forward.
