Scope of Review	The project is subject to location, character, and extent review under section 17.05 and 17.07 of the Richmond City Charter.		
Project Description	Staff Review: The project proposes significant pedestrian and bike infrastructure improvements along Lombardy		
	Street. This corridor is an important connection between VUU to points south of I-95. Maggie Walker Governors School will also benefit from the improved pedestrian access, enhancing safe routes to school for students.		
	The Master Plan shows "Bicycle Facilities" as being located on North Lombardy Street – which this project is fulfilling.		
	The UDC recommended during CONCEPT review, and the Planning Commission approved, that the Applicant explore alternative treatments for the transition between the bike lane and the shared use path.		
	The Applicant has not made changes to the proposed plans and offers the following statement to help the Commission understand the reasoning behind the design.		
	"The shared/split use path is a part of the scope of the SMARTSCALE funding for the project. The SMARTSCALE funding application ["the application"] says to improve pedestrian and bicycle accommodations and connectivity along Lombardy and to provide critical safety improvements to the deficient bridge over CSX. The shared/split use path is specifically proposed in "the application" as a protected bicycle and pedestrian path for multi-modal connectivity. Also from "the application", "the proposed improvements include a protected shared use path along a load path redundant structure which will allow pedestrians and cyclists to travel between Northside Richmond to BRT facilities, separated from vehicular traffic. The existing bike lanes along Lombardy Street will be connected to the path over the bridge by constructing ramps."
