Call to Order

Council President Cynthia Newbille called the meeting to order at 6:01 p.m. and presided.

Invocation was offered by Reverend Joshua Mitchell of 31st Street Baptist Church, 823 N. 31st street, Richmond, Virginia.

Members of Council and the audience recited the Pledge of Allegiance.

Chamber Emergency Evacuation Plan Announcement and Citizen Speaker Guidelines

Upon the President's request, Deputy City Clerk RJ Warren provided information on the appropriate manner in which the Council Chamber is to be evacuated in the event of an emergency along with citizen speaker guidelines.

Awards and Presentations

Council President Cynthia Newbille, on behalf of City Council, and Mayor Levar Stoney honored and recognized indigenous peoples in Richmond, and proclaimed and established the second Monday in October annually, to be known as Richmond Indigenous Peoples' Day.

Council President Cynthia Newbille, on behalf of City Council, and Mayor Levar Stoney honored and recognized the Sigma Gamma Rho Sorority, Inc., in honor of its 100th anniversary, and also acknowledged Sigma Gamma Rho Sorority, Inc.'s Iota Sigma Alumni Chapter for its 87 years of service in the Richmond community.

Citizen Comment

Glenda Cooper, retired city employee, addressed Council and stated her concerns with the lack of raises for retired city employees through the city's retirement system. Ms. Cooper requested that Council identify funding in the next year's budget for an annual increase of compensation for retirees.

Patrice Carpenter, retired city employee, addressed Council and stated her concerns with the lack of raises for retired city employees through the city's retirement system. Ms. Carpenter requested that Council prioritize funding in the next year's budget for an annual increase of compensation for retirees.

Rayford Lee Harris, Jr, retired city employee, addressed Council and requested that Council review an annual cost of living adjustment for city retirees in future city budgets. Mr. Harris stated that he understood certain fiscal obligations the city had, but he requested that Council understand the financial burdens that city retirees experience.

Sophia Owens addressed Council and stated her concerns with the lack of completed infrastructure in her Governors Retreat neighborhood. Ms. Owens informed Council that due to the Governors Retreat developer experiencing financial difficulties, certain infrastructure such as the paving of roads and installation of streets lights and signage were never completed. Ms. Owens requested that the city assist with the completion of infrastructure projects.

Councilwoman Reva Trammell stated her appreciation for Ms. Owens informing Council of the issues in her neighborhood. Councilwoman Trammell also stated she would work with Governor's Retreat residents and city administration to address the concerns raised.

Christina Brockwell addressed Council regarding the accidental death of her daughter that occurred in the James River. Ms. Brockwell informed Council that she believed the James River lacked sufficient signage and warnings addressing river safety. Ms. Brockwell requested that Council, Richmond Fire, and city administration work to increase safety and awareness of possible dangers for individuals that partake in river activities.

President Cynthia Newbille requested that city administration speak with Ms. Brockwell regarding river safety in the city.

Josh Bilder addressed Council and stated his concerns with the establishment of an adult focused store near the Children's Museum of Richmond. Mr. Bilder also stated his concerns with the location due the store's proximity to an emergency shelter for abused women.

Councilor Katherine Jordan noted she was aware of the concerns Mr. Bilder raised. Councilor Jordan informed Council that the store was adhering to city regulations and could not be prevented from operating. Councilor Jordan further stated actions the store planned to take to address concerns, such as what items would be displayed in storefront windows.

Councilor Ann-Frances Lambert stated her appreciation for Mr. Lydiard's comments and requested that citizens continue to engage with Council.

Public Hearing

Allan-Charles Chipman spoke in opposition to ORD. 2022-261, and requested that Council continue consideration of the ordinance to allow time for amendments to strengthen the proposed civilian review board (CRB). Mr. Chipman stated any CRB should have disciplinary authority over police employees. Mr. Chipman also stated that a CRB should incorporate the recommendations provided by the Task Force for the Establishment of a Civilian Review Board.

Jessee Perry spoke in opposition to ORD. 2022-261, and stated her opposition was due to the lack of disciplinary measures that the proposed CRB could make. Ms. Perry also stated she was concerned that the public assumed that the ordinance was to be amended and continued to a future meeting, and she requested that the ordinance be continued even though the legislation was not amended.

Tom Barbour, Richmond City Democratic Committee Resolutions Committee chair, spoke in opposition to ORD. 2022-261, and stated his concerns that residents could have assumed the ordinance was to be amended and continued, and therefore did not attend the meeting to provide public comment. Mr. Barbour also stated that he believed the proposed CRB was not strong enough to ensure police accountability due to the lack of disciplinary powers.

Nathan Ellis, Richmond for All member, stated that Richmond for All supported a CRB that provided clear oversight of the Richmond Police Department, but he informed Council that he did not believe the proposed ordinance provided that. Mr. Ayers further stated a strong CRB was necessary for citizens to feel safe in the city.

Maisie Osteen, Legal Aid Justice Center attorney, spoke in opposition to ORD. 2022-261, and stated that she did not believe it provided the police oversight for which the Richmond Transparency Accountability Project (RTAP) advocated. Ms. Osteen also stated that without the ability to fully investigate, the CRB proposed in ORD. 2022-261 would be too weak to accomplish any oversight.

Yohance Whitaker, Legal Aid Justice Center community organizer, RTAP member, spoke in opposition to ORD. 2022-261, and stated that the ordinance would create an inefficient CRB. Mr. Whitaker also stated that a weakened CRB would lead to the Richmond Police Department's continued harassment of Black people in the city.

Khalah Sabackhan spoke in opposition to ORD. 2022-261, and stated Council should think of individuals police abused when considering the proposed ordinance.

Da-Twoine Fields spoke in opposition to ORD. 2022-261, and stated Council should incorporate more data analysis when reviewing police interactions with the public. Mr. Fields also stated that police should be required to answer to the community.

Portnoy Johnson spoke in opposition to ORD. 2022-261, and stated a well established CRB would ensure sufficient oversight of law enforcement actions that the public could trust.

Keisha Cummings, 2Love, LLC founder, informed Council of her personal experiences with police officers.

Charles Willis, United Communities Against Crime executive director, spoke in support of ORD. 2022-261, and stated that Council shouldn't delay the CRB proposed in ORD. 2022-261. Mr. Willis also stated that he believed many individuals that spoke against the ordinance were not long-term residents of the city.

Councilor Ann-Frances Lambert stated that a reimagining of police interactions was necessary in the city. Councilor Lambert informed members that she no longer supported her proposed amendment to the legislation and that it was time for Council to move forward on the proposed CRB.

Councilor Stephanie Lynch addressed how the city's adoption of collective bargaining would impact the proposed CRB.

President Cynthia Newbille stated her appreciation for comments citizens provided, and she informed the public that Council would have opportunities in the future to amend and refine the CRB referenced in ORD. 2022-261.

Councilwoman Reva Trammill stated her concerns with the lack of support for the city's police employees, and she also stated her concerns about the potential impact of ORD. 2022-261 on the city's ability to retain police officers.

There were no further comments or discussions and ORD. 2022-261 was unanimously adopted.
