Staff Report

A motion was made by Commissioner Danese, seconded by Commissioner Nutt, to partially approve this application with conditions for the reasons stated in the Staff Report. Specifically, the Commission denied infilling any portion of the existing masonry openings on the building with brick or framing; the proposed replacement vinyl windows; and the installation of light posts in the front yard. The Commission approved the following with conditions: replacement windows

be wood or aluminum clad wood, fit within the original masonry openings, and have a one-over-one light configuration to match the appearance of the original windows documented in the historic photograph; all architectural features of the porch including the turned posts, corbels, brackets, and spindle work be repaired or replaced with an exact match; front porch railings match the historic turned pickets and be inset into the top and bottom banisters, or the picket must match the existing square pickets; new decking boards be installed perpendicular to the face of the building and be tongue and groove; and all unpainted masonry must remain unpainted.
