<u>Update on the General Assembly Legislative Session and the American Rescue Plan (ARP)</u> <u>Act and Federal Advocacy</u>

Laura Bateman and Ron Jordan, Advantus Strategies, provided an update regarding consequential legislation enacted in the 2021 General Assembly Session along with an overview of the ARP Act and other federal relief to be received by the city. A copy of the information provided has been filed.
