#### Call to Order

Council President Cynthia Newbille called the meeting to order at 6:00 p.m., and presided.

## **Spanish Interpretation Announcements**

Councilor Ellen Robertson addressed the requests of budget public hearing speakers, and she noted her concerns about the difficulty of city employees being able to afford living in the city. Councilor Robertson also stated that the Office of Community Wealth Building (OCWB) is a city institution that provides an essential service to city residents in need of assistance. Councilor Robertson further stated her support for collective bargaining, and she requested that the city be prudent in working with vendors that provide city government with contracted workers.

Vice President Katherine Jordan stated her appreciation for individuals and organizations that provided her with feedback related to the proposed city budget.

Councilor Ellen Robertson moved that the budget related ordinances be continued to the Monday, April 28, 2025, Formal Council meeting, which was seconded and unanimously approved.
