Whereas, The National Public Safety Telecommunicators Week is held the second full week of April and is an annual observance on behalf of telecommunications professionals first recognized by the Congress of the United States of America in 1991; and

Whereas, The Richmond Department of Emergency Communications 9-1-1 Emergency Communications Center is ranked the second busiest center in the State of Virginia and is staffed by more than 90 dedicated professionals who provide a human voice and help in critical times of need;
