OVER \$1 BILLION IN IMPACT

\$1.1 billion in federally supported programs are at risk if reimbursement delays continue.

Across **130** federally funded programs:

- 13 will remain fully operational.
- 98 will operate in partial or suspended capacity.
- 19 will terminate operations immediately without additional funding.





PROGRAMS MOST AT RISK

The **Department of Social Services** and the **Department of Housing and Community Development** have the most immediate risks to continuity of services due to the federal government shutdown.





Note: Today, November 3, 2025, the Federal government announced that it will pay 50% of November's SNAP benefits.

INITIAL MITIGATION ACTIVITIES



Fiscal: Activate bridge funding and defer discretionary expenditures to sustain operations.



Operational: Prioritize critical DSS and HCD services for vulnerable populations.



Administrative: Maintain continuous coordination with the Virginia Department of Social Services, DSS, HCD, and Department of Finance.



Communication: Provide consistent updates to stakeholders and the public regarding service availability and funding impacts.



OUR NAVIGATION FRAMEWORK

- 1. Mitigate the local economic harm of the federal shutdown
- 2. Absorb additional stress on local operations and services, in part by activating existing Continuity of operations (COOP) plans and services
- 3. Protect low-income and other vulnerable residents
- 4. Stay connected to our federal partners
- 5. Advocate for our community
- 6. Communicate, COMMUNICATE, COMMUNICATE

DEPARTMENT OF HOUSING & COMMUNITY DEVELOPMENT (HCD)



PREPARING FOR PROJECTED CUTS

- If HUD stops all reimbursements for federal programs (CDBG, HOME, HOPWA, and ESG).
 63 projects, 33 agencies, and 10 employees would be directly impacted.
- 2. HOPWA funding supports 102 households, covering short-term rental & financial assistance, placement in Permanent Supportive Housing, and rental assistance.
- ESG and CDBG subrecipients who provide services will have elevated costs due to increased demand, as a result of cuts in other areas.
- 4. Critical and substantial home repair projects that are in progress will be prioritized based on emergency or safety and funding availability.



PROJECTED IMPACT

- \$488,000 average monthly agency reimbursements across programs
- \$73,410 monthly reimbursement to cover HCD staff
- 102 families could potentially lose housing, as the City currently provides \$139,250 average every month for the three providers (CCC, Serenity, and Support Works)
- This will result in the city spending more money on the front-end, without guarantees that draw down's will be available. The monthly average costs will also increase due to increased need.
- This will impact properties where work has begun. HCD will need to prioritize what to complete and what to put on hold or discontinue.

CAUTIOUSLY PROCEEDING

- HCD continues to process HUD FY26 item plans and contracts, cautiously aware that if HUD stops reimbursements for federal programs, there will no longer be funding available for these projects.
- HCD continues to process invoices for the nine (9)
 FY25 contracts that were funded within HUD
 guidelines.

PROJECTED IMPACT

- Continued uncertainty for City subrecipients.
 - Note: HCD has asked our subrecipients to process invoices promptly and to keep us informed if other funding complements begin to impact their program.
- Currently, no impact; funds are available, and drawdowns are actively being processed.



BUSINESS AS USUAL (FOR NOW)

- The City's current mode of operation is business as usual until HUD provides additional guidance. Currently, HCD is allowed to draw down available funds.
- 2. HCD is processing FY26 item plans and contracts.
- 3. HCD is processing invoices for FY25 extended contracts.

CURRENT IMPACT

No current impact. However, the City has proactively sent letters to subrecipients, informing them of our progress in grant management and encouraging them to keep the City informed of any changes to the programs we currently fund.



DEPARTMENT OF SOCIAL SERVICES



WHAT'S REQUIRED

THE CITY OF RICHMOND

Each locality **must** annually appropriate sufficient funds to provide for social service programs — including administrative costs.

Local governments must operate all public assistance and social services **regardless of reimbursement timing**. (§63.2-400)

THE COMMONWEALTH OF VIRGINIA

The Commonwealth **must** reimburse localities for expenditures "within the limits of state appropriations." However, it **does not guarantee immediate payment** during a shutdown. (§63.2-401)

DSS must operate all core programs regardless of reimbursement delay. The City must front-fund essential services using local reserves or bridge funding, and the Commonwealth remains legally obligated to reimburse once appropriations are restored.

The Administration is <u>hopeful</u> that the impasse ends soon, and these commitments are kept.





Grant-funded DSS staff will remain supported through the end of the fiscal year.



The City's may lose up to \$3.6 million per month in federal reimbursements.

DSS STAFFING COSTS

Time Period	Staff Time Calculation	Accrued Payroll

- Average monthly reimbursement shortfall from the federal government for staff costs: \$3.6 million
- Average daily DSS payroll: \$136,741
- As of September 2025, DSS had 369 FTEs **84.5% of costs** subject to state/federal reimbursement
- The average daily DSS payroll is **\$136,741 per day**; (excluding overtime, special funds payroll expenditures, and salaries for three newly onboarded positions post-September 25).



CURRENT MITIGATION ACTIVITIES

IMPLEMENTED

Hiring Freeze: Temporary hiring pause for positions vacated after September 30, 2025. 29 positions in recruitment have been paused. This method may be extended to non-federally funded programs.

Projected savings through December 1: \$897,735 (< 7 days of staffing costs)

POTENTIAL

Operational Savings: Delayed purchasing of needed equipment for the new DSS office: AV, scanners, technology, additional security cameras, and furniture for the new DSS office move. If delayed much, these expenditures would need to be added in FY27.

Potential savings: Estimated at approximately \$2.6M

LAST RESORT

Staffing Payroll Adjustments: If delays persist, short-term payroll and staffing adjustments may be necessary. This may include extending hiring freezes beyond federal programs, followed by more severe actions.




SNAP RESOURCES & PROGRAMMING



SNAP'S MASSIVE IMPACT

Supplemental Nutrition Assistance Program (SNAP) serves the largest population of any federally supported program.

- Over 22,000 households, totaling 38,000 Richmond residents currently receive SNAP benefits each month
- Nearly 20% of Richmond's population relies on this assistance
- 10,000 students receive SNAP (48% of RPS students receive SNAP)
- 172,000 recipients across Central Virginia





FEDERAL SNAP WORK REQUIREMENT CHANGES

Starting November 1, 2025

Age

Before: Adults 55 or older were exempt.

Now: That age limit is raised to 65.

Families

Before: Household including a child under 18 were exempt.

Now: That age drops to 13.

Fewer Automatic Exemptions

These groups will no longer be automatically exempt:
Adults who are homeless*, veterans, young adults 18–24
who left foster care

* People chronically homeless (6 months or more) can still be exempt.

CITY OF RICHMOND

IF YOU ALREADY HAVE SNAP BENEFITS

- These new rules will apply when your case is reviewed or renewed.
- Until then, your current exemption stays the same
- If your situation changes (like work hours, who lives in your home, or disability status), your case might be reviewed sooner

STATE + LOCAL RESPONSE TO THE SHUTDOWN

The federal shutdown has disrupted SNAP benefits for over 22,000 Richmond households. Here's how we're collectively responding.

THE COMMONWEALTH OF VIRGINIA

Virginia will launch the **Virginia Emergency Nutrition Assistance** (VENA) program starting November 3, 2025. However, recipients will still face initial food benefit gaps and **reduced purchasing power** due to the weekly payment structure.

THE CITY OF RICHMOND

To fill the gap, the City has partnered with Feed More, Richmond Public Schools, and regional partners to implement a food distribution and outreach strategy targeting the most vulnerable populations.



VIRGINIA EMERGENCY NUTRITION ASSISTANCE (VENA)

- Total statewide weekly allocation to VENA:
 \$37.5 million
- Weekly payments will be 25% of the participant's monthly SNAP benefit
- VENA will have the same eligibility requirements as SNAP
- Participants approved to receive SNAP prior to October 29, 2025 will receive VENA
- VENA payments will continue through November (unless the federal shutdown ends)
- Benefits will be delivered weekly via existing SNAP EBT cards beginning the week of November 3

VENA PAYMENT STRUCTURE AND TIMING

Benefits on 1st of month	Every Monday	November 3
Benefits on 4th of month	Every Wednesday	November 5
Benefits on 7th of month	Every Friday	November 7



FOOD DISTRIBUTION PARTNERSHIP

Even with VENA, SNAP recipients will have less purchasing power due to VENA's weekly payment structure and will experience an initial period of one or more days without benefits as a result of the federal shutdown.



To address this, the City has been working with our regional partners and key stakeholders such as Feed More and RPS to develop a coordinated response.



The goal is to ensure awareness of available resources and increase food distribution across Richmond starting the first week of November.



The City and partners will assess weekly to determine the allocation and coordination needed for the following week based on information at the time.



FOOD DISTRIBUTION STRATEGY

- The City will invest \$100,000 to support increased food distribution
- Greatly increase distribution at five key food pantry sites at strategic locations throughout the City
- Provide direct distribution to 10 target housing developments serving priority populations
- Promote 22 existing weekly Feed More partner food pantry locations
- Partner with RPS on a centralized "school market" for RPS families who qualify for SNAP and face additional barrier to food access. Additional planning is being done to expand the weekend backpack distribution of food at target schools.









RICHMOND'S FOCUSED OUTREACH

Special focus is being placed on ensuring resources and information is accessible to the following **priority populations**: Immigrant and refugee communities, individuals experiencing homelessness, older adults and individuals with disabilities, Children and families

- The City is working with internal and external subject matter experts and stakeholders to ensure the community has clear and accurate information about VENA and other food resources, including Shalom Farms mobile market locations.
- Office of Neighborhood Engagement is facilitating feedback from civic association leaders and public housing communities.
- We are printing hundreds of postcards and the Office of Immigrant and Refugee Engagement is ensuring critical information is available in appropriate languages.
