Personal Property Tax Relief for Vehicles Analysis - based on vehicles sited in the City 1/1/18

If 100% Tax Relief is granted for vehicles assessed \$1,000 or less:

- * Approximately 15,900 vehicles would receive 100% relief
- * Qualifying vehicles assessed over \$1,000 would receive 53% relief

If 100% Tax Relief is granted for vehicles assessed \$1,500 or less:

- * Approximately 33,000 vehicles would receive 100% relief
- * Qualifying vehicles assessed over \$1,500 would receive 51% relief

Approximately 184,000 vehicles in the City qualify for tax relief
